When I was driving on the way and just middle position between the Tinbatti more to NHPC and suddenly from wrong side a Two-wheeler with one person without Helmet kept coming towards me speedily and the said person lost the control his two wheeler & hit my Two wheeler(WB 74Y 9979) as a result we are both fell out on the road and received some injury & also found Head light & Head light Cover of my Two wheeler is broken badly.

IT IS ALSO MENTION HERE THAT, THE SAID TIMES NO BIG VEHICLE WAS GOING WHEN WE FELL ON THE ROAD OTHERWISE WE WOULD HAVE TO FACE A BIG DANGER.



But when picked up my wife in a TOTO [short vehicle] for dropping to her School as she was getting late for go to school, that time he was able to escape with his two wheeler from the said place.


