I, Mahuya Sarkar, wife of Dipankar Das, D/o. Late Manoranjan Sarkar, of Debalaya, Nibedita Sarani, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling would like to report you the following facts:-

1. That Dipankar Das, Son of Late Upendra Chandra Das resident of Loke Nath Nagar, P.O. + P.S. Bagdogra, Dist. Darjeeling is my legally married husband.
2. That soon after marriage my husband started to torture me both physically and mentally for demand of dowry and my sister in-law namely Mithu Barman, wife of Tapas Barman and Mother in-law Usha Rani Das, used to instigate my husband to inflict torture upon me. They use to tell me to bring cash Rs. 15,00,000/- for buying flat and a car. In the name of my husband and also gave him cash Rs. 7,00,000/- for purchasing land but I inspite of that they were not satisfied and thereafter on the ground of I have no issue they started to torture me in new and different manners so, that I may leave the house and they would marry my husband somewhere else and my husband and in-laws never provided any medical treatment to me for my infertility. I with the help of my family members any how get my checkup done and the Doctors advised me some medication and also suggested for IVF but my husband did not support me in the said medical treatment and told to bring money from my father's house for the treatment and seeing my future my father gave Rs. 2,00,000/- for IVF treatment but inspite of that my husband refused to go for IVF and when I requested him then he, his mother Usha Rani Das, his sister Mithu Barman drove me out from

my in-laws house on 17.09.2015 empty handed and since thereafter I have been residing in my parent's house.

My husband never came to see me nor contacted with me rather I came to know he had illegally married with one lady namely Manjuri Das without obtaining divorce from me.

3. That my all document and clothing and valuable articles are lying in my in-laws house.
4. That today at about 1PM I went my in-laws house for bringing my Adhar Card and Birth Certificate and requested my mother in-law to give the same to me and then I told them If they do not give the same to me I would file case against them and hearing this they became furious and my husband started to assault me with fists, blows and told that he would kill me so that I could not file any case against them and my mother in-law and said Manjuri Das poured kerosene oil on my body and tried to burn me by lighting match stick but I blew off the match stick so the fire could not catch and then my husband started to strangled me with intention to kill me but any how I managed to flee away from there.

Had I not blew off the match stick and escaped from there they would have definitely murder me.

I therefore, requested you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.
