I, Smt Kajal Ghosh @ Jharna (28) w/o  
Sri Vivek Ghosh @ Tipu, presently residing  
at Gp Ramu Biswas, Tyoti Nagar (Near Kales  
Mandir), Ward No. 5 same, P.O. Siliguri Bazar,  
PS-Siliguri, Distt- Darjeeling, beg to inform  
you that, my marriage was solemnized with,  
Vivek Ghosh @ Tipu s/o Late Arun Ghosh of above  
noted address, under Hindu rites & rituals, nearly  
12 (twelve) years back, and after my marriage  
I came to know that my said husband and his  
family members, used to reside inside the Khatpura  
Red-light area and used to do flesh trade  
and since then my said husband & his family  
members, started subjecting me for physical and  
mental cruelty and threatened me to engage me  
in said illegal trade, but I denied to do so and  
my father-in-law namely, Arun Ghosh s/o Late  
Haradhan Ghosh, gave me his Tea shop at Viveka,  
Nanda Boud (Near Coal Depo), PS-Siliguri, and me  
and my husband used to earn our bread with the  
help of said tea stall, and my said father-in-law  
died on 07.10.2020, and my said husband & his  
relatives always tried to evict me from the said  
shop after the death of my father-in-law, and  
they threatened me to engage in red-light area,  
in their brothel.

On dt. 17.11.2021 at about 01:10 pm my said

(1) husband, his mother namely (2) Smt. Malati Ghosh  
w/o Late Arun Ghosh and his sisters namely (3)  
Smt. Alpina Biswas w/o Sri Rony Biswas (4) Smt.  
Babli Ghosh D/o Lt. Arun Ghosh, along with others  
told me to leave the said tea shop and threatened  
me to work in Red light area and when I protested  
my said husband felt Hot Milk on my body and  
they started beating me with feet and blows  
and evicted me from my shop and threatened me to  
work as sex worker. So, please take necessary  
action against my said husband & his above named  
relatives & others for subjecting me for physical & mental  
Cruelty & menacing.
