I, Smt Aparna Roy Wife of Sri Naba Kumar Singha, Daughter of Jyotish Chandra Roy, Resident of West Hatlyadanga, P.O. Sahudangi Hat, P.S. Bhaktinagar, Dist- Jalpaiguri, Pin-735135, would like to state you that I got married with one Sri Naba kumar Singha, Son of Amal Singha, Resident of Mulaijote, Lalmon, Bhujjapani P.O. & P.S. Bagdogra, Dist- Darjeeling, Pin-734014, on 02/01/2018 under the Special Marriage act, before Smt. Jayanti Paul, Marriage Officer, Bhaktinagar Jalpaiguri. That before marriage said Naba Kumar Singha represented himself in front of me as a noble person and his romantic activities towards me compelled me to feel attraction upon him. That due to the said love and affection for each other we tied ourself in a matrimonial relationship and started to live together as husband and wife but soon after our marriage I felt said Naba Kumar Singha i.e. my Husband has a real cunning and mischievous face behind his portrayed face which he represented in front of me before the marriage.

That after a lapse of only one month my husband, Sri Naba kumar Singha showed his real colour as he started to create several kind of nuisance and unlawful activities in my peaceful life. He often came to house in a drunken condition and use to pick-up quarrel in trifling issues and also tortured me both physically and mentally. He often ordered me to bring Dowry from my parents. Due to such violent and immoral nature of him I compelled to live a hectic and painful marital life with him. That in the month of August, 2018 my husband came to the house in a drunken condition and started to beat me with fists and blows and also threw most abusive languages towards me and to save my life I was compelled to run away from my matrimonial house and took shelter at my paternal house.

Since then I made every effort to save my conjugal life but due to violent nature of my husband my all effort went in vain. That on 16/11/2021 at about 09.00 pm suddenly my husband viz. Sri Naba kumar Singha entered to my paternal house and started to create nuisance in front of my other family members and when my father asked him to leave our house he started to throw most filthy and abusive languages toward me and my father. When I raised objection against his such immoral activities he started to beat me and also tried to drag me in front of my parents. However after intervention of my father and my mother I somehow managed to escape from the evil clutches of my husband, Sri Naba kumar Singha.

That presently I am very much scare about my life and also life of my family members as my husband may again come to our house and will create same kind of scene as he done it earlier.

I therefore requesting you to take drastic legal action against my husband, Sri Naba Kumar Singha in accordance of law and your good office is very much expected in this regard.
