Out of our wedlock a son named 'Suraj Sarkar' was born in the year 1995.

My father-in-law have one son i.e. my husband and 4 Nos. of daughters, all are married and lived in the same locality. As such each and everyday they have interfered in every matter in my family and torture me since the marriage, during this period my father-in-law died; thereafter all my sister-in-laws started stay in the house and highly physically and mentally torture upon me by demanding dowry, and abusing, quarrelling, assaults me several occasions, As such I stayed at my parents house at Shakti Nagar under PS. Phansidewa, Dt. Darjeeling some time. That the Govt. has acquired ^{our} some land and for the inhabitation had given a plot of land in the name of Sailendra Nath Sarkar and Smt. Kanchar Sarkar in joint names. As my husband was teacher by occupation have constructed in the said plot of land a two storied pucca house from his income and buy all house hold goods, ornaments etc and a Ford car Regn No. WB 74BF-0441, which was sold by the culprits.

That my husband died on 05-05-2021 due to Covid-19 at that time I was not present at home and stayed at my parents house after highly tortured by my mother-in-law, Smt. Kanchar Sarkar ① Navak's Smt. Bharati Biswas ② Smt. Smriti Bain ③ Smt. Falguni Poddar ④ Smt. Sechitra Mahato and husband ⑤ Sri Subhojit Mahato and driven from the house as such I was bound to stay at my parents house with son and till now stayed there on. The above named culprits have not allowed me in the house and threatened me to kill me and my son.

That I have also informed to the local police-station earlier of my torture. I several time try to settle our dispute but the culprits have never allow me, though they have always insulted, assaulted and torture me physically and mentally. After death of my husband they have attempted to kill me and my son when I along with son reached at house. The culprits Smt. Suchitra Mahato and Sri Subhojit Mahato and his men attacked on us. On 23-05-2021 at 10.30 AM when I with some relatives gone to meet with my Sasuri then found our house was locked and my Sasuri is in the house of Smt. Suchitra Mahato at same area.

That till now said house of my husband is key and locked by Sasuri and she is resides with her said daughter house in the same area. The said house hold goods has been thefted by Smt. Suchitra Mahato and Subhojit Mahato including golden ornaments.

That above named culprits are very dangerous persons they may commit any offence with me and my son with intend to grab all my husband's property. On 14-11-2021 my Sasuri called me over telephone and threaten me with dire consequence, if I did not give NOC for sale of house and other property and kill me.

Therefore, I request you sir, please inquire the incidents and take necessary action against the culprits namely
 ① Smt. Kanahan Sarkar ② Smt. Bharati Biswas ③ Smt. Smriti Bain
 ④ Smt. Falguni poddar ⑤ Smt. Suchitra Mahato ⑥ Sri Subhojit Mahato and save me my son and my husband's property from their hands.
