Respected Sir,

With due respect, I, **Smt. Piyasha Halder**, Wife of Sri Ratan Halder and Daughter of Sri Ratan Halder, residing at C/O. Sanjib Halder, Kawakhari, Kalam Jote, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling-734012 (W.B.), beg to state as follows:-

- 1) That I have entered into marriage with one Sri Ratan Halder, Son of Late Narayan Halder of Sukanta Pally, Near Sishu Malancha School, P.O. Siliguri Bazar, P.S. New Jalpaiguri, Dist. Jalpaiguri on 27.01.2019 according to Hindu Rites and Customs and at the time of marriage, my father given gold ornaments, Refrigerator, Washing Machine, TV, Micro Oven, Steel Almirah, Khat, Alna, Dressing Table as per demands of said Ratan Halder and his mother Smt. Putul Halder.

That after marriage, I have started to live together with my husband Sri Ratan Halder in their house but expiry of 1(one) month, my husband demanded a sum of Rs.2,00,000/- only and also asked my father to complete the grill works in their incomplete house and my father has been compelled to pay the said amount of Rs.2,00,000/- only to my husband and has also compelled to complete the grill works by spending a sum of Rs.1,50,000/- only.

That thereafter, again my husband and my mother-in-law demanded a sum of Rs.3,00,000/- only but when my father refused to give the same, my husband, my mother-in-law and uncle of my husband namely Rabin Halder physically assaulted me by slapping, broom etc. on 15.09.2019 and in the month of April 2019, when I have found my mother-in-law and said Rabin Halder in a illicit manner, they have increased torture upon me and threatened me that

they will kill me if I will disclose the same, they will kill me.

- 4) That on 21.11.2019 at night, my husband, my mother-in-law and said Rabin Halder assaulted me by hatching my hair, by fists and blows and kicks and also tried to commit murder by pressing pillow on my mouth and for saving my life, somehow I could escape from their hands and I returned to my father at Bharat Nagar, Siliguri and I have been treated on 22.11.2019 by the doctor of North Bengal Medical College & Hospital as I had sustained bleeding injuries.
- 5) That I have intimated the matter to the O.C., N.J.P. Police Station on 19.12.2019 but no action has been taken and subsequently, on 10.09.2020, my husband, mother-in-law and said Rabin Halder came to the house of my father at <sup>Shree Pally</sup> Bharat Nagar, Siliguri and claimed a sum of Rs.5,00,000/- only and when my father refused the same, they have destroyed household articles of the house of my father and subsequently, they have threatened that if my father will not pay the same, they will kidnap me.
- 6) That due to fear of kidnap, my father shifted me to my uncle i.e. full blooded younger brother of my father namely Sanjib Halder on 16.09.2020, situated at Kawakhari, Kalam Jote, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling but on 20.01.2021 in the evening, my husband, mother-in-law and said Rabin Halder came to the house of my uncle Sanjib Halder and tried to physically assault me and threatened that if my father will not pay a sum of Rs.5,00,00/- only, they will kidnap me.
- 7) That on 04.04.2021, again my husband along with my mother-in-law, said Rabin Halder and others forcibly entered into the house of said uncle Sanjib Halder and claimed a sum of Rs.5,00,000/- only but when I refused, they have physically assault me by fists and blows.
- 8) That inspite of inhuman torture by my husband, mother-in-law and said Rabin Halder, I have not taken any steps immediately after the incident on 16.09.2020, 21.09.2020 and 04.04.2021 but as they have been continuing to

torture me, even after shifting to the house of my uncle Sanjib Halder at Kawakhari, I have no option but to lodge this complaint for saving my life as well as for the punishment of my husband, my mother-in-law and said Rabin Halder.

So, I therefore, request you to take necessary legal action against my husband Ratan Halder, my mother-in-law Smt. Putul Halder and said Rabin Halder, - all are residing at Sukanta Pally, Near Sishu Malancha School, P.O. Siliguri Bazar, P.S. New Jalpaiguri, Dist. Jalpaiguri. And for this kindness, I shall much oblige to you.
