Sir,

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Biswanath Chowdhury (62/M), S/O Late Bhagaban Chowdhury of Sutki Godown, P.O+ PS- Matigara, Dist-Darjeeling under arrest along with following seized articles viz , 1] 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.2 liters, value Rs 120X12=1440/-) and marked as 'exhibit -A' and 2] one bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1" under seizure list which is enclosed herewith) to the effect that on 21.11.2021 at 22.10 hrs received a secret source information that one person namely Biswanath Chowdhury (62/M), S/O Late Bhagaban Chowdhury of Sutki Godown, P.O+ PS- Matigara, Dist-Darjeeling has stored huge quantity of Illicitly country spirit at his at his hotel without any valid license. Diarized the matter vide Matigara PS GDE No 1034 Dt- 21.11.2021 accordingly I informed the matter to O/C Matigara PS and as per kind direction of O/C PS myself along with ASI Nilal Mondal, Const- 1035 Santosh Rabi das, Const- 1008 Karak Roy, CV- 155 Sukumar Das left for Sutki Godown to verify the veracity of the source information. On reaching at the spot at 22.35 hrs it was found that huge quantity of Illicitly Country Spirit stored in the hotel of Biswanath Chowdhury who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the hotel. But we apprehend the above noted person namely Biswanath Chowdhury. There after I called two independent witnesses of that locality namely I) Ananda Barai (22), S/O Golok Barai of Shimultala, P.O+PS- Matigara, Dist-Darjeeling and II) Shibu Singh (32), S/O- Tapan Singh of Tumbajote, P.O+ PS- Matigara, Dist-Darjeeling and in the very presence of those witnesses I search the hotel and seized the above noted Illicitly country spirit after preparing proper seizure list duly signed by the two independent witnesses and apprehend the person namely Biswanath Chowdhury. On being asked the said person failed to produce any document for selling and storing liquor at the hotel. It's a violation under Bengal Excise Act. This seizure was made on 21/11/21 in between 22:40 hrs to 22:55 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Biswanath Chowdhury (62/M), S/O Late Bhagaban Chowdhury of Sutki Godown, P.O+ PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said hotel and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Biswanath Chowdhury (62/M), S/O Late Bhagaban Chowdhury of Sutki Godown, P.O+ PS- Matigara, Dist-Darjeeling and arrange for its investigation.
