Sir,

In producing herewith the arrested accused person namely Jiban Roy (19 yrs) S/O Habul Roy of Sabita Bhawan, Ward No-37, Ghugumali, PS- Bhakti Nagar, Dist. Jalpaiguri and the following articles under seizure. The ground of arrest duly been communicated with him.

1. One Motor Cycle displaying number plate WB/74/AB/5344 (Hond Ghine 125 Optimax).
2. One motor cycle displaying number plate WB/74/N/4942 Black & Red Color Hunda Stunner C.B.F.
3. One black colour Activa 4G without displaying any number plate.
4. One CBZ Black and Red Color displaying No-WB/74/S/ 4351.
5. One Red Color CBZ without displaying any number plate.

I, SI Goutam Mallik of NJP Police PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused Person to the effect that on 17.11.2021 at 08.15 hrs I received reliable secret source information that one Jiban Roy of Sabita Bhawan, Ward NJo-37, Ghugumali, PS- Bhakti Nagar, Dist. Jalpaiguri is proceeding towards his residence by a stolen Motor Cycle from NJP Railway Station. Accordingly, I diarized the matter in GD vide NJP PS GDE No 674 Dated 17.11.2021 and informed the fact to you and as per your kind direction myself along with ASI Sajal Roy, ASI Khagen Barman VP/08 Laxman Roy and VP/13 Jamirul all of NJP PS left the PS to verify the veracity of the information. At 08.35 hrs we managed to intercepted one motor cycle displaying number plate WB/74/AB/5344 (Hond Ghine 125 Optimax) at near IOC Gate, NJP being driven by one person. On being asked he disclosed his identity as noted above. On demand he failed to produce any documents in respect of the motor cycle in his possession. During further interrogation he disclosed that he stolen the said motor cycle from NJP parking area. Accordingly, I seized the said motor cycle under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. After his arrest he further disclosed that he kept another 04 (four) numbers of stolen Motor Cycle at NJP parking area. Accordingly, as per his leading statement and being shown by him I recovered more 04 (four) numbers of stolen Motor Cycle displaying number plate (1) WB/74/N/4942 Black & Red Color Hunda Stunner C.B.F (2) One black colour Activa 4G without displaying any number plate (3) One CBZ Black and Red Color displaying No-WB/74/S/ 4351 and (4) One Red Color CBZ without displaying any number plate. Accordingly, I seized the said 04 (four) numbers of stolen Motor Cycle under proper seizure list. The search seizure and arrest made in between 08.50 hrs and 09.50 hrs on 17.11.21. During enquiry it is learnt that he is a habitual criminal of motor cycle theft and he along with others continuously stolen motor cycle from NJP and Siliguri area since long.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be registered against namely Jiban Roy (19 yrs) S/O Habul Roy of Sabita Bhawan, Ward No-37, Ghugumali, PS- Bhakti Nagar, Dist. Jalpaiguri and arrange for its investigation.
