Sir,

In producing herewith the two arrested accused persons namely (i) Jogendra Kumar (24 yrs) S/O Satta Narayan of Thakurain Kheda, Bakuliha, PS- Khero, Dist.- Rai Berili, Uttar Pradesh and (ii) Bhupendra Kumar (21 yrs) S/O Binod Kumar of Srinath Khada, PS- Morama, Dist.- Unaa, Uttar Pradesh and the following articles under seizure. The ground of arrest duly been communicated with them.

1. One silver colour small vehicle (Maruti Breeza) displaying number plate WB/74/AU/9068.
2. One driving license issued by Uttar Pradesh having license number UP-35-20190005972, date of issue 27.05.19 and valid up to 26.05.2039 in the name of Bhupendra Kumar.

I, SI Samik Paul of NJP Police PS, SPC do hereby lodged this written complaint against the above mentioned arrested two accused Persons to the effect that on 19.11.2021 at 18.30 hrs I received reliable secret source information that one stolen small vehicle is coming from Ghosh Pukur side and proceeding towards Assam for its clandestine disposal. Accordingly, I diarized the matter in General Diary vide NJP PS GDE No 787 Dated 19.11.2021 and informed the fact to you and as per your kind order and direction myself along with ASI Sajal Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Kr Yadab all of NJP PS left for Fulbari Toll Plaza to verify the veracity of the information. At 18.50 hrs we arrived at Fulbari toll Plaza and started to Naka Checking. At about 19.15 we noticed one Maruti Suzuki vehicle displaying number plate WB/74/AU/9068 is coming from Ghosh Pukur side and we managed to stopped the vehicle at Fulbari Toll Plaza and found two persons inside the said vehicle including the driver. On being asked the driver of the said vehicle disclosed this identity as Bhupendra Kumar (21 yrs) S/O Binod Kumar of Srinath Khada, PS- Morama, Dist.- Unaa, Uttar Pradesh and another one disclosed his identity as Jogendra Kumar (24 yrs) S/O Satta Narayan of Thakurain Kheda, Bakuliha, PS- Khero, Dist.- Rai Berili, Uttar Pradesh. On demand they failed to produce any valid documents in respect of the said vehicle. On interrogation they give different statement in different time and finally they disclosed that the vehicle is stolen one and they proceed towards Assam for its clandestine disposal. There was sufficient reason to believe that the said vehicle is stolen one. Hence, I seized the said vehicle displaying number plate WB/74/AU/9068 under proper seizure list and arrested the above noted two accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 19.35 hrs and 19.55 hrs on 19.11.21.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under propedr section of law may kindly be registered against accused persons namely (i) Jogendra Kumar (24 yrs) S/O Satta Narayan of Thakurain Kheda, Bakuliha, PS- Khero, Dist.- Rai Berili, Uttar Pradesh and (ii) Bhupendra Kumar (21 yrs) S/O Binod Kumar of Srinath Khada, PS- Morama, Dist.- Unaa, Uttar Pradesh and arrange for its investigation.
