Sir,

I, ASI Tapan Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Lalchand Munda (40/M) S/O Lt. Sakhiram Munda of Lichu Bagan, P.O- Nema, P.S- Matigara, Dist.- Darjeeling under arrest along with following seized articles viz ; 1] one white colour jar containing total 10 (Ten) Liters of local made illicit Liquor (Chullu) and marked as 'exhibit - A' and 2] 01 (one) liter of local made illicit Liquor (Chullu) taker. from "Exhibit-A" for examination and marked as "Exhibit-A-1" under seizure list (which is enclosed herewith) to the effect that on 22.11.2021 at 17:35 hrs received a secret source information that one person Lalchand Munda (40/M) S/O Lt. Sakhiram Munda of Lichu Bagan, P.O- Nema, P.S- Matigara, Dist.- Darjeeling has stored huge quantity of Illicitly country spirit at his at his house without any valid license. Diarized the matter vide Matigara PS GDE No.1069 Dt.- 22.11.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with ASI Nitai Mondal, Const- 1035 Santosh Rabi das, Const- 1008 Kanak Roy, CV- 155 Sukumar Das left for Lichu Bagan to verify the veracity of the source information. On reaching at the spot at 17.50 hrs it was found that huge quantity of local made illicit Liquor (Chullu) stored in the house of Lalchand Munda who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Lalchand Munda. There after I called two independent witnesses of that locality namely i) Golok Barai (42), S/O-Lt. Bhim Barai of Shimultala, P.O+PS- Matigara, Dist-Darjeeling and ii) Shibu Singh (32), S/O-Tapan Singh of Tumbajote, P.O+ PS- Matigara, Dist-Darjeeling and in the very presence of those witnesses I search the house and seized local made illicit Liquor (Chullu) after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Lalchand Munda. On being asked the said person failed to produce any document for selling and storing of local made illicit Liquor (Chullu) at the house. It's a violation under Bengal Excise Act. This seizure was made on 22/11/21 in between 18.05 hrs to 18:25 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Lalchand Munda (40/M) S/O Lt. Sakhiram Munda of Lichu Bagan, P.O- Nema, P.S- Matigara, Dist.- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of local made illicit Liquor (Chullu) at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.


Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Lalchand Munda (40/M) S/O Lt. Sakhiram Munda of Lichu Bagan, P.O- Nema, P.S- Matigara, Dist.- Darjeeling and arrange for its investigation.
