Jaigaon, Dist. Alipurduar, Presently residing
at Iskcon Road, Siliguri-734001 would like
to inform you that on 18th of November 2021
I, along with my friends went to Hotel
Gateway Restaurant cum bar at Sevoke
Road for leisure purpose. On that very
day at around 10.30 PM I along with my
friends were coming out of the said
hotel, while at that very moment all of
sudden Saikat Rajawat Resident of
North City, Room no 606, 6th floor, and
Shahnawaz Hussain Resident of Dangipara,
Siliguri along with 30 (thirty) companions

attacked me & my friends just outside the Hotel Gateway. They attacked us using Puppets, Knives, metal Rod and sharp objects like knives etc. and also snatched my gold chains, Purse and beated me up fiercely. I would like to precisely mention that Sourav Rajawat took a loan previously from me of an amount of Rs. 6,57,999/- and when I asked him to repay the said amount he denied to repay the same and also threatened me that if I ask him to repay the same he will kill me to death and than alongwith Shekharwaraj Hussain, Sourav Rajawat on a continuous basis started harrasing me over phone and personally asking for more money and threatening me that if I ask for previous money and deny them to give more money they will not allow to reside me here in Siliguri and wanted will ~~me~~^{me} to death

And finally on 18th November 2021, Souvar Rajawat alongwith Sheh Nawaz Hussain attacked on my and my friends, namely, Subham Mahato, Satyam Roy and Ritvik Sharma. They attacked on us just outside the Hotel using various objects such as Knuckles, metal rod and sharp objects like knives, metal rod and injured me and my friends grievously. Later on when no one came to our rescue I, ran away from there with my friends or else they would kill us to death.

I, would also like to precisely mention that Sheh Nawaz Hussain has also threatened me to pay him certain amount of money on a regular basis. Sir, I want to wish stay and continue my ^{daily} business and livelihood in Siliguri and if I failed to pay them I will be killed to death.
