I, Md. Ziaul Hoque, Son of Md. Reazul Hoque, working for gain as Sub - Inspector of Police, presently posted at Bhaktinagar Police Station under Siliguri Police Commissionerate and presently residing at Bhaktinagar Police Station Barrack, would like to inform you that my marriage was solemnized with Sufia Yasmin on 18<sup>th</sup> day of June, 2006 at her parental house situated at Village -Chandipur, Post Office -Sovanagar, under Police Station -Englishbazar, District -Malda. After our marriage, on 22<sup>nd</sup> day of June, 2006, I brought her to my then residence at Mallaguri Police Quarter, at Mallaguri Police Lines, Post Office & Police Station - Pradhannagar, Siliguri, District -Darjeeling, where we started living our conjugal bliss. Thereafter, she got admission in Department of Law under North Bengal University to pursue her study for Bachelors Degree in Law and thereupon, she got admission for pursuing the course of Auxiliary Nurse Midwife (ANM) at MJN Hospital at Coochbehar, both of which she successfully completed. It is pertinent to mention here that her entire studies were completely sponsored by me being responsible husband and, at all times, I enthusiastically encouraged her to pursue her studies. After successfully completing the course of ANM, she got appointed as Health Assistant (Female) at Matigara Block Primary Health

Suddenly thereafter, since from the month of January, 2017, my wife started to behave abnormally and her attitude towards me became very much rude and crude day by day. She turned into an extremely short and ill tempered woman, crude and highly whimsical and without any plausible reason used to hurl abusive languages showing serious antipathy against me. Whenever, I used to return from my duty, she used to get furious for no rhyme and/or reason and started abusing and insulting me in front of my family members, neighbors, friends and relatives. She even started badly taunting me for the nature of my job as a police officer. With days passing, it became a routine for her to abuse and insult me in front of my family members, neighbors, relatives and friends, and she regularly started taunting me and insulting me for no reason. She always used to threaten me that she would desert me at any moment since now she has got a government job for herself. With efflux of time my matrimonial life became an awful tale and my relationship with my wife turned from bad to worse due to the systematic cruel and ill treatment meted out to me by her.

Since we were living in Police Quarters, for all these times I was making some savings by adding penny by penny, month by month, from my meager salary with a dream to have our own house and finally on the 3<sup>rd</sup> day of July, 2014, a land admeasuring 2 katha situated at Government Colony, Post Office & Police Station -Matigara, District -Darjeeling was purchased, completely out of my own savings, in my wife's name. Thereafter, I started construction of a dwelling house therein and by the

upon me by always humiliating, abusing and insulting me in front of my family members, relatives, friends and neighbors and by taunting me for no reasons.

Sometime later, I noticed landslide changes in her behavior and attitude and she stopped allowing me to get close to her and would always taunt me by saying that I am not worthy for her. I tried in every possible way to convince her and to pacify the situation by showing my love, care and affection but all went in vein and she grew more and more furious and the quantum of my humiliation, abuse and insult in front of my family members, relatives, friends and neighbors by her increased with each passing day. She even started assaulting me in front of others. On numerous occasions, she assaulted me by fists and blows as well as by kicks, and also by continuously slapping me and scratching me by her nails, and on some occasions even by weapons, in front of my family members, relatives, friends and neighbors, as well as, in front of our house maid. She has been always very arrogant and rough in temperament and always misbehaved with me every now and then with great harassment and cruelty but I remained silent with hope that the situation would get better someday and also I was much willing and keen to save and settle my matrimonial life peacefully with her but all went in vein and my dream for a happy conjugal life shattered into pieces. Owing to her rude, crude, cantankerous and unruly nature, character and temperament, my life has become miserable.

On the 16<sup>th</sup> day of November, 2021, at about 05:00 pm, over the issue of coming of my parents at our house and allegedly not bothering of my wife's parents, all of a sudden started abusing me using filthy languages inside our bed room. When I protested and tried to convince

year 2017, the construction of our G +3 storied residential house was completed by utilizing the entire savings I had made in all these days and further, by monetary help of my father, which he had received after his retirement from School Teacher, to make arrangements for expenditures which were incurred for the construction of the said dwelling house, in which my wife also made a meager contribution. But despite of all my sincere and best efforts I put to make our conjugal life happy and prosperous, the behavior of my wife towards me became more and more cruel and she used to treat me with extreme contempt and apathy. She used to abuse and insult me each and every moment by addressing me with filthy and humiliating language in front of others and treated me with extreme cruelty.

Meanwhile, on the 23<sup>rd</sup> day of January, 2018, a male child was begotten out of our wedlock, whereupon, I thought that my wife will understand and mend her ways and the situation will get better with efflux of time by the arrival of the newborn but the situation got worse. The continuous abuses and insults meted out to me by my wife and her continuous crude gestures, obnoxious and crude behavior shocked me, as well as, my family members, neighbors, relatives and friends. She started picking up quarrels with me upon trivial grounds and for no reasons every now and then thereby creating a chaos in the house every day, causing tremendous mental trauma to me and also to our little son. She always used to address my parents, family members, relatives and friends in an abusive way using slangs and filthy language and humiliated them every moment causing my life miserable. She would never take care of me nor ever have/had any love, attachment, care and affection towards me and caused tremendous mental torture and cruelty

her that there was nothing as such, then, she came out of to our common room, I also came out from our room and tried to pacify her. Meanwhile our, maid Aroti came. My wife took out hammer from Almirah and tried to assault me but due to intervention of our maid she could not hit me. Our maid ultimately snatched said hammer from the hand of my wife and threw the same away. But then also my wife was not controllable, then, I went inside our room, there, she scratched over my arms and elbows with her nails and assaulted me by fists and blows. The entire event has been recorded in the CCTV installed at our house. As I believe in law of the land, I was calm and composed and for not to escalate the situation, I wanted that to come out of my house and go somewhere else in order to mitigate the situation but my wife illegally restrained me and kept on abusing me and assaulting me as per wish with fists and blows. But I did not dare to raise a hand against her. Meanwhile, I somehow, I came out from my house, so that my wife would get calm. Then after, I was constrained to call my father -in -law viz., Md. Serajul Islam, my mother -in -law viz., Selima Khatun, my brother -in -law viz., Dilwar Hossain, all permanent residents of Village - Chandipur, Post Office -Sovanagar, under Police Station -Englishbazar, District -Malda, along with my sister viz., Nasera Khatun and my brother viz., Md. Abdul Motalib, whereupon a meeting between me and my wife was held on 19<sup>th</sup> November, 2021 at our house in their presence, wherein again my wife along with my above named father -in -law, mother -in -law and brother -in -law assaulted me verbally in presence of my brother and sister. They drove me out of my house along with my brother and sister saying that since my house stands in the name of my wife, they will now grab it for their own and will not allow me to live in peace. even threatened me with dire consequences if in case I ever dare to come close to my house or dare to claim it.

I was tremendously shocked and mentally traumatized by the entire incident to such extent that I lost my ability to think and speak for quite some time since I never thought even in my dreams that such an incident could ever happen to me. I could not rationally decide for sometime as what to do. Only after elapse of a period of time, I regained my full consciousness and am hereby lodging this complaint in regard to the afore stated facts and circumstances.

Therefore, kindly take notice of the aforesaid facts and circumstances and take legal action to set the law of the land in motion to impart me justice, for which I shall ever pray.
