Sir,

In producing herewith four (04) arrested accused persons namely 1) **Birju Manky Munda** @ Koushik Manky Munda(19) S/O Lt Kishan Manky Munda of Dhaknikata,near Prakash da house PS. Pradhannagar,Dist. Darjeeling. 2) **Ganesh Roy** @ **Baw** (19) S/OLt Biran Roy of Normodabagan, river side Somornagar PS. Pradhannagar,Dist. Darjeeling 3) **Abdul Hussain** (21) S/O Ahamad Hussain of new Prakashnagar, near Hanuman Mondir W/No.43,Ps-Bhaktinagar,Dist Darjeeling. 4) **Rahul Kr. Mahato** (20) S/O Krishna Mahato of sri Ramnagar, Dhaknikata, Champasai PS. Pradhannagar,Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made SWORD measuring about 27 inch (approx) including wooden butt from the possession of Abdul Hussain which was kept on his right hand,
- (2) One iron rod measuring 16 inch one side claw (approx) from the possession of Ganesh Roy which was kept on his right hand, with one white colour torch, which was kept on his left hand
- (3) One iron hammer measuring 11 inch (approx) with butt from the possession of Birju Manky Munda @ Koushik Manky Munda which was kept on his right hand.
- (4) One iron Kukri measuring 14 inch (approx) with wooden butt from the possession of Rahul Kr. Mahato which was kept on his right hand.

I, ASI- Debasish Das of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. and others to the effect that today on 24.11.2021 at 00.15 hrs in course of my mobile van duty period received a sources information that 11/12 youths have assembled at Dagapur football ground with a view to commit docoity in a house at that area. The information share with you and as per your direction, myself along with PSI- Youel Lepcha, ASI Ashit Singha, Const.704 Ratan Rai, Const. 974 Mintu sen , CV 645 Pankaj Gupta , CV-223 Swapan Chhetri and CV - 992 Jagadish Biswas and others left P.S to work out the information, vide Pradhannagar PS GDE No-1290 dated 23/11/2021. When we reached near Dagapur football ground at around 00.45 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the vacate land near Dagapur football ground on seeing police personnel. They tried to flee away but after a long hot chase we managed to apprehend the above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at that area.

I thereafter, seized the above noted weapons under proper seizure list and labelled duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 01.05 hrs to 01.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Pradhannagar P.S for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house near Dagapur area. It is also revealed from them that (1) Birju @ Koushik 2) Ganesh Roy @ Baw 3) Abdul Hussain 4) Rahul 5) Suraj Chhetri 6) Raju Roy 7) Kalu 8) Santosh and others assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. 1 Birju Manky Munda @ Koushik Manky Munda(19) S/O Lt Kishan Manky Munda of Dhaknikata,near Prakash da house PS. Pradhannagar,Dist. Darjeeling. 2) Ganesh Roy @ Baw (19) S/OLt Biran Roy of Normodabagan , river side Somornagar PS. Pradhannagar,Dist. Darjeeling. 3) Abdul Hussain (21) S/O Ahamad Hussain of new Prakashnagar, near Hanuman Mondir W/No.43,Ps-Bhaktinagar ,Dist Darjeeling 4) Rahul Kr. Mahato (20) S/O Krishna Mahato of sri Ramnagar, Dhaknikata, Champasai PS. Pradhannagar,Dist. Darjeeling of Do and others and arrange for its investigation.
