Sir,

I, Md. Azad son of Md. Sattar, resident of Assam Rail gate, Shiv Nagar, Post office and Police Station- Pradhan Nagar would like to state that yesterday at around 8 P.M. when my father went to saloon of Rama Thakur situated at Shiv Nagar vegetable market a person namely Md. Nizam son of Late Md. Bashir resident of Satyajit nagar was counting money and when my father entered he pushed my father for entering the premises without knocking.

Later one of my friend namely Rahul Shama called me and stated the matter to me so I rushed to the market and bought my father back to home.

At 9.30 P.M 15 to 20 men under the leadership of said Md. Nizam, Md. Salim, Md. Ali, Rishrat Khatoon, Sabana Khatoon, Father of Sabana Khatoon (name not known), Saira Khatoon and Salma Khatoon came to my house and started to hit me without stating any reason. When my father came they started to hit my father followed by family members including my sisters and my wife. Md. Nizam, Md. Salim and Md. Ali physically assaulted my sisters and my wife followed by all the persons in which my sister namely Chandni Khatoon was severely injured and is presently admitted to Siliguri Hospital.

Lastly requesting you to take necessary action as per law against the said persons as per law and save us from their torcher.
