It is to state that, Mangal Das and Mithun Rai were working at our house as a painter on 24th October 2021, around 5pm, he was working in front of our Grandmother's room without informing our Grandmother. ₹ 6000/- (six thousand six hundred only) cash and two golden rings are missing. He stated that he had entered the room only to switch on the light which was not necessary at all (without permission). My sister was at another room which was latched from the outside.

It is very regret to say that no male guardian is present, as our uncle who is an Indian Army is recently posted in Srinagar, Jammu and Kashmir which is a sensitive area. We want the police to take some necessary and strict action against them.
