Re: In producing herewith one arrested accused person namely Madan Mohan Barman (20) s/o Mangal Barman of Bottle Company, Bihari Basti, Ward No. 41, Baikunthapally, PS Bhaktinagar, Dist. Jalpaiguri along with the following seized articles viz:

1. Twelve (12) bottles of HIT SUPERSTRONG BEER each bottle containing 650 ml.
2. Four (04) bottles of ROYA BLUE Premium Whisky each Bottle containing 750 ml.

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodge this written complainant against the above noted arrested accused person to the effect that on 20/11/2021 at around 18:05 Hrs received a source information that one person has gathered huge amount of liquor illegally in his House situated at Bottle Company for selling the same to local customer for his wrongful gain. Accordingly I, informed you about the information and as per your kind instruction, I along with, C/374 Debraj Biswas, CVF/ 619 Dharmendra Roy, CVF/014 Labanyamoy Barman of Bhaktinagar PS/SPC headed towards Bottle Company to work out the information. At 18:20 hrs we reached at the spot, and after being shown by the source I, along with force entered the House and apprehend one Person who disclosed his identity as noted above and searched his house and recovered above noted seized articles. On demand of License or Documents for storing and selling the above noted seized liquor, he could not produce the same. During enquiry he admitted his guilt before us and stated that he has been selling the liquor to local customer since long for his wrongful gain. I, then prepared seizure list of the above noted articles in presence of witnesses undersigned of seizure list. The seizure was made between 18:40 Hrs to 18:55 Hrs. I arrested the said accused person u/s 41 Cr.P.C after observing all the formalities and issued Memo of arrest appraising the ground of arrest to him.

I therefore request you to kindly register a specific case against the accused person namely Madan Mohan Barman (20) s/o Mangal Barman of Bottle Company, Bihari Basti, Ward No. 41, Baikunthapally, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
