With due respect, I Kedar Khemraj Lamer,  
D.O. (P.O.), D. No. 500, C. part at Kankarpang,  
D.O. office, resident of Sabai, S.D. had  
purchased a Tata Manjeer Vehicle from Jata  
Motors, Chak. Post (New Vega Circle) about a  
year back. From since purchase, the vehicle  
was defective in nature & the above named  
persons who are the Sales Manager at Jata  
Motors promised me to change the

new one.

During this period, the cost of
