

With due regards, I, **SMT. RIMA GHOSH**, Wife of Sri Rajdeep Ghosh, Daughter of Gobinda Ghosh, Presently residing at Haider Para, Shibram Pally, A.P.C. Sarani, Ward No. 39 of S.M.C., P.O. Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006, in the State of West Bengal, would like to lodge this written complaint to the effect that **SRI RAJDEEP GHOSH**, Son of Sri Dipankar Ghosh, Resident of Surya Nagar, Ward No. 8, Alipurdwar, P.O. Alipurdwar Court, P.S. & Dist. Alipurdwar, is my legally married husband and our marriage was solemnized on 08.05.2016, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house. It is to be mentioned here that our marriage was a negotiated marriage and our marriage was negotiated through the mediator (Ghatak) namely Smt. Supriya Ghosh who is the neighbor of my in laws members. It is also to be mentioned here that at the time of my marriage, my parents and other family members have given so many valuable articles like golden ornaments, furniture & fixtures, utensils, clothing's and other valuables which are required to start a new conjugal life, as per the demand of my husband and in laws members. After my marriage, my husband brought me at his house as mentioned aforesaid where we started to live and co-habited together as husband and wife and in my matrimonial house, besides me and my husband, my parents-in-law and one brother-in-law have also resided there. I entered into my matrimonial house with lots of dream and hope with a view to lead a happy conjugal life with my husband and in laws members. Just after entering into my matrimonial house, my mother-in-law came to my room and asked me to handover all the jewelries and other valuables which are "Stridhan" in her favour and as per her direction, I have handed over all the jewelries and other valuables to my mother-in-law which I have received at the time of my marriage as well as on the day of reception ceremony. After my marriage, I have passed my martial life with my husband and in laws members only for a period of three months. Immediately after lapse of three months, my parents-in-law as well as my husband restricted me to talk with my family members or any neighboring peoples of my matrimonial house and they have also restricted me to talk with my college friends as at the time of marriage, I was studying in 2nd Year in Philosophy Department (Hons) at Siliguri College and at the time of negotiation of our marriage, my husband as well as my in laws members assured me

made a self declaration that in the month of June, 2020, my husband came at my parental house and make apology before me and my family members and also brought me at Siliguri and treated me and during my stay at my parental house, in the month of June, 2020, my husband came at my parental house and mental torture, I have fallen ill and hearing my illness, my parents and mental torture, I have fallen ill and hearing my illness, my parents

and my parents that they will definitely allow me to continue my future studies but very surprisingly, immediately after my marriage, my husband and in laws members created so many pressure upon me to stop my studies and when I made protest against their said acts, they became furious and started to create torture upon me and finally, I have compelled to stopped my studies in the middle portion. Thereafter, my mother-in-law in conspiracy with other in laws members have shifted the entire burden of household works upon me and compelled me to do all the household chores in my matrimonial house and considering my future conjugal life, I have started to work as per their full satisfaction. They stopped to provide me sufficient foods and forced me to eat the wasted foods of the house and considering the said situation, sometimes, I used to sleep at night in empty stomach and my husband has every knowledge about the said fact but he did not make any protest against his mother and other family members for which, I had fallen ill and during my illness, neither my husband nor my in laws members take any care upon me and did not bother to brought me before the Doctor and as and when, I requested my husband to took me before the Doctor considering my health condition, they asked me to bring money from my parental house. In the mean time, I became pregnant and during my pregnancy, I have to forced to do all the household chores and on 10.11.2017, I gave birth a male child at Alipurduar St. Merry's Nursing Home, whose name is Master Ritambar Ghosh and after delivery of the said child, they have asked my parents to pay the 50% amount of the total expenditure as per their rituals and finally, inspite of starvation, my father has bear and pay the 50% of the delivery charges for the sake of my conjugal life. After delivery, the Doctor advised me to complete bed rest for a period of three months but due to the pressure of my mother-in-law and other in laws members, I was compelled to do all the household chores immediately after seven days of my delivery. Before the occasion of Durga Puja Ceremony in the year of 2018, my husband asked my mother to pay a sum of Rs. 30,000/- for starting a new business and for the sake of our happy conjugal life, my mother has accumulated the said fund and pay the said amount to my husband. In spite of receiving the said amount from my mother, day by day, they increased the torture both physically and mentally upon me and they also provoked me either to follow all the directions or to commit suicide and they also threatened that as they are involved with the political party, nobody will do anything against them. They have also restricted my son not to mix with me and they keep my son away from me. My husband also broken my SIM card so that, I could not able to contact with my parents and other family members. In the year of 2020, I again admitted at Netaji Subhas Open University in order to complete my B.A. Course and after completion of all the household work, when I try to keep my mind in the study, they asked and threatened me not to continue my study by using the light and fan. Presently, my son is aged

about four years but my husband and my other in laws members did not make any arrangement for his study. Due to their continuous physical and mental torture, I have fallen ill and hearing my illness, my parents brought me at Siliguri and treated me and during my stay at my parental house, in the month of June, 2020, my husband came at my parental house and make apology before me and my family members and also made a self declaration that in future he will not commit any type of torture upon me and after furnishing the said declaration, I again return back to my matrimonial house but immediately after returning to my matrimonial house, my husband and other in laws members in conspiracy with each other again started to create inhuman torture upon me both physically and mentally and due to their said torture, I asked my husband as to why you bring me from my parental house on the false plea that you will not commit any torture upon me and hearing the same, my mother-in-law came there and told my husband to driven out me from my matrimonial house immediately and when I objected against their such type of behavior, they became more furious and assaulted me physically. Thereafter, finding no other alternative, on 13.11.2021, my mother and other family members came to my matrimonial house in order to discuss and solve the disputes but they did not bother to allow them in my matrimonial house and misbehaved with them by using filthy and abusive languages and finally, they driven out me and my minor son from my matrimonial house forcefully and finding no other alternative, I along with my minor son return back to my parental house accompanied by my mother and other family members with a single dress and since then I along with my minor son have been residing at my parental house and during my stay at my parental house, my husband in conspiracy with other in laws members, threatened me with dire consequences and asked me to handover my minor son in their favour and give my consent on the mutual divorce as he wants to marry with another girl, otherwise, he will not hesitate to ruin my life as well as the life of my family members. Sir, due to the constant threatening from my side of my husband and in laws members, I along with my family members passed our life with extreme fear and anxiety.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband and other in laws members as per the provision of law and obliged thereby.
