Dear Sir,

This is for your kind information  
that on Sunday morning i.e. 21<sup>st</sup> November  
around 08:40 A.M my daughter <sup>Addya</sup> Shankar  
along with her friend was riding bicycle and  
returning home in Uttarayan. Just few meters  
behind Uttarayan township a speeding military  
truck hit my daughter from behind leading  
to severe injury. The place of injury is (about)  
between Chandmuni mandir and Uttarayan gate.

My daughter Addya Shankar and her friend Manje  
Goel were coming from Darjeeling more to  
Uttarayan. The incident occurred and military  
truck had stopped 10 to 20 meter ahead. They  
saw the injured girl from there and fled  
away without helping her to bring to the  
nearby hospital. The Attitude of this callous  
behaviour is against the army people and  
Civil Society.

Kindly do necessary action against such  
behaviour and incident.
