Sir,

In producing herewith the one accused person namely Narayan Roy (38), S/O- Ganesh Roy of Janatanagar W/No. 44, PS Bhaktinagar, Dist- Jalpaiguri along with seized vehicle bearing No. WB 73 E 9555 with loaded seized articles.

I ASI. Deepak Kumar Singh of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 26.11.2021 at 00:05 hrs while my Night Van duty I received a information from my reliable source that one vehicles bearing Reg. No. WB 73 E 9555 loaded with stolen river bed materials coming from Tarabari Side . On receiving the information I along with force and available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Tarabari, under Matigara P.S area, I found one vehicle bearing Reg. No. WB 73 E 9555 loaded with river bed materials going towards Bihar. Subsequently, I manage to stop the vehicle and found loaded river bed materials on demand he failed to produced valid documents for carrying river bed material. As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the accused driver namely Narayan Roy (38), S/O- Ganesh Roy of Janatanagar W/No. 44, PS Bhaktinagar, Dist- Jalpaiguri on proper memo of arrest and brought to the above noted vehicle and accused at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle under proper section of law and arrange for its investigation.
