
I S.I. Sandeep Subba of Panitanki Traffic Guard, SPC beg to lodge a written complaint against One Milan Barui (Male- 33 years) S/O Ananda Barui or Barui Engineering, Coolie Para, P.O. Junction, Siliguri, Dist. Darjeeling loaded 02(two) Iron Sheets, 03(three) pcs Iron Bar in a Van and moving through a busy Traffic Junction at Airview More towards Siliguri Junction in a dangerous manner with high possibility of fatal accident as the length of the Van is almost three times less than the length of the goods carried. Finding no any alternative way I arrested him U/S- 41(1) (a) Cr.P.C. after proper briefing about the ground of arrest & supplying a copy of memo of arrest. Accordingly I also seized the above mentioned articles from the possession of the said person mentioned above U/S-102 Cr.P.C after preparing proper seizure list duly signed by the witnesses. The said articles were given in Zimma to Milan Barui himself after observing all formalities.

Hence, I would, therefore request you to kindly start a specific case U/S- 188 IPC and 283 IPC against the above noted accused person and oblige.
