In producing herewith one accused person namely Kakoli Das (F/50 yrs.), W/O Lt. Rajesh Das, of Nabagram Banaful Sarani, Near Winners Club W/NO-33,PS-NJP,Dist - Jalpaiguri along with seized articles vize i) 20(Twenty) sealed bottles of Himalayan Gold 60up country spirit ( each bottles containing 600ml. @ Rs 120/- each amounting of Rs. 120/- X 20= Rs. 2400/-)in which one sealed bottle has taken from mother packet box as sample as per seizure list,

I ASI Srijit Paul of Siliguri PS under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 23.11.2021 at 14:30 hrs. received an information. S.F. Road Near Anandaloke Wine Shop under Siliguri PS that one female person has gathered huge quantity of illegal liquor which kept in , S.F. Road Near Anandaloke Wine Shop under Siliguri PS which was kept in one gunny bag for selling the same in the open market for her wrong full gain. Diarized the fact in GD vide Siliguri PS GDE NO - 1347/21, Dated-23.11.2021 . As per your kind instruction myself along with ASI Dhruba Mishra, LC 1295 Swastika Rai, CV 622 Ramantah Barman of Siliguri PS, SPC proceeded to the PO to work out the information . At 15:15 hrs. we reached at the near S.F. Road Near Anandaloke Wine Shop under Siliguri PS sometimes after being identified by the source our police party Found That The Above Noted accused person who busy to sale liquor to the local people. On seeing the police party she tried to flee away. After her chase the above noted accused person was apprehended with the help the lady force. On searching with help of Lady force for the above noted seized article was kept in the gunny bag. On demand she could not produced any valid license/documents in support of said liquor. One enquiry she admitted that she used to sale same in open market for her wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample.  
(The seizure was made in between 15:35hrs. to 16:15hrs. ) then I arrested the accused person U/S 41 Cr. P.C after issuing Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person Kakoli Das-(F/50 yrs.), W/O Lt. Rajesh Das, of Nabagram Banaful Sarani, Near Winners Club W/NO-33,PS-NJP,Dist - Jalpaiguri under proper section of law and arrange for investigation as she violated the norms of Bengal Excise Act.
