Sir,

I A.S.I. Prodig Kumar Bhowmick of Jalpaimore Traffic Guard, SPC beg to lodge a written complaint against (1) Bidhan Sarkar (Male- 36 years) S/O Late Bibhuti Sarkar of Bhanu Bhakta Sarani, Gurung Basti, PS-Pradhan nagar Dist. Darjeeling loaded 02(two) Item Iron Z angle Qty.99.00 kg. and MS angle 40X6 Qty 52.86kg. (2) Rajesh Kumar Sah(Male- 30 years) S/O Ashok Sah of Siwaji Road, Near Santoshi Nagr, W/No-05, PS- Siliguri, Dist. Darjeeling loaded 01(One) Item 01 Colour Sheet(IN-FT) 18 Fouts. (3) Sanjay Das(Male- 34 years) S/O Sunil Kumar Das of Suryasen Colony, Block-B, Majumder Sarani, W/No-34, PS-NJP, Dist. Jalpaiguri, loaded Item Bars and Rods in a Van and moving through a busy Traffic Junction at Jalpaimore towards Siliguri Ramghat in a dangerous manner with high possibility of fatal accident as the length of the Van is almost three times less than the length of the goods carried. Finding no any alternative way I arrested him U/S- 41(1) (a) Cr.P.C. after proper briefing about the ground of arrest & supplying a copy of memo of arrest. Accordingly I also seized the above mentioned articles from the possession of the said persons mentioned above U/S-102 Cr.P.C after preparing proper seizure list duly signed by the witnesses. The said articles were given in Zimma to (1) Bidhan Sarkar, (2) Rajesh Kumar Sah, (3) Sanjay Das, themself after observing all formalities.

Hence, I would, therefore request you to kindly start a specific case U/S- 188 IPC and 283 IPC against the above noted accused persons and oblige.
