Respected Sir,

With due respect I, **SMT. MIRA BARUA**, Wife of Late Dulal Barua, Resident of Mahakal Pally, Near Suryasen Park, Ward No. 10 of SMC, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin -734001, would like to lodge this written complaint to the effect that I am aged about 63 years and being the Senior Citizen, suffering with severe old aged ailments. Sir, due to the mental and physically torture of my elder son Sri Pradip Barua and his family members, I along with my deceased husband have filed an application U/S 4, 20 & 23 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 before the Sub-Divisional Officer, Siliguri vide Misc. Petition Case No. 26/2020 and during the continuation of the said case, my husband Dulal Barua expired on 20.05.2021 and thereafter, on 29.07.2021, Ld. Court was pleased to pass an order as per the provision of Maintenance and Welfare of the Parents and Senior Citizenship Act, 2007, including an order directing my elder son to pay a sum of Rs. 3,500/- only month by month to me. After passing the said order, my elder son has paid a sum of Rs. 3,500/- only for the month of August, 2021 and Rs. 3,000/- only for the month of September, 2021 and thereafter, he did not pay any amount as per the order of the Ld. Court. In the month of October, 2021, when I asked my elder son to pay the monthly maintenance amount, he flatly refused to pay the same in compliance with the Order of the Ld. Court and since then, my said son and his entire family members became more violent and misbehaved with me in every manner and thereby, caused mental torture upon me again. Sir, the roof of my room where I have been residing is Tin shaded old one and poor condition and as my elder son and his family members are not looking after me, I requested my younger son to repair the said Tin shaded room as water is being leakage from the roof during rainfall and as per my request, my younger son Dilip Barua has arranged



the mason and labors for repairing the same and today i.e. 24.11.2021 at about 11.30 A.M., when the engaged mason and laborers have started to work for repairing my said room, my elder son along with his family members have obstructed them to repair the same and also threatened them with dire consequences by saying them if they continue the said repairing works, they will not bother to assault them and put them behind the bar. Due to their said illegal acts, when my younger son Dilip Barua has raised objection and also requested them to allow the mason and laborers to continue the repairing work, they became furious and started to assault my younger son with the help of iron rod and as a result, my younger son has received severe injury on his head and when I tried to rescue my younger son from their clutches, they have also assaulted me physically. Sir, I am a helpless widow lady and a senior citizen, have been facing lot of sufferings both physically and mentally from my elder son and his family members and if they are not restrained from committing their illegal acts and activities, there is every possibility of loss of my life.

I, therefore, being a senior citizen, fervently requesting you to look into the matter properly and please take necessary legal steps against my elder son namely Sri Pradip Barua and his wife Smt. Jhuma Barua and others for causing mental and physical torture upon me and also for causing physically assault upon my younger son and obliged thereby.
