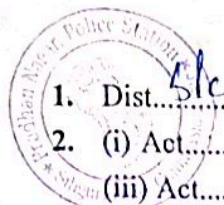

SUB: First Information Report

Sir,

With due respect, I am producing herewith one accused Namely Babulal Tudu (M-34) S/O. Sri Meghrai Tudu of Majhua busty PS- Pradhan nagar Dist- Darjeeling (Driver of Pickup van bearing reg no. WB 73D/8640) Under arrest along with seized one Pickup van bearing reg no. WB 73D/8640 loaded with stone (River bed materials) respectively.

I beg to report that today i.e 26.11.2021 I was engaged in Special mobile van duty under PS area, with C/ 1446 Nirmal Roy and C/1413 Sujit Sarkar ,vide M.C.C No. 2897 and PDN PS GDE No. 2413 dated. 26.11.21. I was patrolling near Milan More area under Pradhan Nagar PS and found that above noted pickup van was coming from Milan More picnic spot side towards Debidanga. I told the driver to stop the vehicle but driver did not pay any heed to me and tried to flee away with his vehicle. We chased him and managed to stop the above noted pickup van and detained the driver. On interrogation he disclosed his identity noted above. I asked to the above noted driver to produce any document in respect of loaded stone and vehicle paper, but he failed to produce supporting document regarding said vehicle and loaded stone. He also stated that he loaded the Stone (Riverbed materials) from Milan more picnic spot river bank Under Pradhan Nagar P.S illegally for wrongful gain. So I arrested him U/S 41 Cr.P.C and seized the loaded vehicle under proper seizure list. The Seizure was done in between 09.10 hrs to 09.20 hrs

Therefore, I pray before you that a specific case under proper section of law may kindly be Initiated against the accused person viz: Babulal Tudu (M-34) S/O. Sri Meghrai Tudu of Majhua busty PS- Pradhan nagar Dist- Darjeeling (Driver of Pickup van bearing reg no. WB 73D/8640) and arrange for its investigation.
