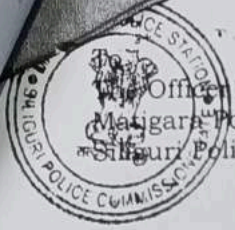

Subject: FIR

Sir,

In producing herewith one arrested accused person namely Ilambo Roy(32), S/O- Trailakhy Roy, of Paulpara, P.S- Matigara, Dist-Darjeeling along with one seized vehicle bearing no- WB- 73-5002(Shaktiman) loaded with river bed materials under proper seizure.

I, ASI Tapan Das of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Ilambo Roy(32), S/O- Trailakhy Roy, of Paulpara, P.S- Matigara, Dist-Darjeeling the driver of Seized vehicle bearing no- WB- 73-5002(Shaktiman) loaded with river bed materials to the effect that today on 26.11.2021 at 19.15hrs. received a specific source information that one vehicle bearing no- WB- 73-5002(Shaktiman) loaded with river bed materials had been moving along the road towards Tumbajote Jora bridge. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS myself along with assisting force left PS to verify the veracity of source information. On the way towards Tumbajote Jora bridge I detained a vehicle bearing no- WB- 73-5002(Shaktiman) loaded with river bed materials near West Point School, Tumbajote, Matigara and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Ilambo Roy(32), S/O- Trailakhy Roy, of Paulpara, P.S- Matigara, Dist-Darjeeling. On demanded he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no- WB- 73-5002(Shaktiman) stated that he is the owner of the vehicle bearing no- WB- 73-5002(Shaktiman). He also stated is involved in carrying of river bed materials by illegal means for his wrongful gain since last few months. Accordingly I seized the vehicle bearing no- WB- WB- 73-5002(Shaktiman) being loaded with river bed materials and subsequently arrested the driver named Ilambo Roy(32), S/O- Trailakhy Roy, of Paulpara, P.S- Matigara, Dist-Darjeeling. The whole process of seizure and arrest was made in between 20.25 hrs to 20.55 hrs.

Hence, I pray that a specific case may kindly be started against the driver namely Ilambo Roy(32), S/O- Trailakhy Roy, of Paulpara, P.S- Matigara, Dist-Darjeeling of above noted vehicle bearing no- WB- 73-5002(Shaktiman) loaded with river bed materials under proper section of Law and arrange for its investigation.
