
- i) **21(Twenty one) Plastic bottles of Himalayan Gold , Country Spirit ,60 up, each bottle containing 600 ML.**
- ii) **06 (Six) bottle of Kingfisher Strong ,Premium Beer ,each bottle containing 650 ML**

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 26.11.2021 vide PDN PS GDE NO 1444 dtd. 26.11.21 while I was performing Special Mobile van duty at Darjeeling more area with CV/645 Pankaj Gupta ,CV/223 Swapan Chhetri ,During mobile duty at 16.30 hrs I received an information that one person namely Dipak Mahato has storage huge quantity of illegal liquor in his Hotel styles as " Bikash Hotel" at Dagapur near Lokenath Mandir under Pradhannagar PS and selling the same in his Hotel .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the said Hotel and detained the hotel of owner noted above and on being search his hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 16.55 hrs to 17.35 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Dipak Mahato (32) S/O Sri Sankar Mahato of Dagapur, near Lokenath Mandir ,P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
