With due respect and humble submission, in producing herewith one accused namely Benoy Rai (23) S/O Sri Dipak Rai of Coolipara, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 12(Twelve) Plastic bottles of Himalayan Gold , Country Spirit ,60 up, each bottle containing 600 ML.
- ii) 01(One)Plastic bottle of COSMOS FIFTY ,XXX RUM containing 750 ml

I ASI Ashit Singh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 26.11.2021 vide PDN PS GDE NO 1444 dtd. 26.11.21 while I was performing Special Mobile van duty at Siliguri Junction area with CV/992 Jagadish Biswas ,CV/242 Rakesh Mongar ,During mobile duty at 16.35 hrs I received an information that Durga Hotel at Siliguri Junction area storage huge quantity of illegal liquor and selling the same .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the said Hotel and found that one person selling the liquor ,on seeing police party the customer fled away from this hotel ,then I detained the above noted person and on being search said hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 17.15 hrs to 17.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Benoy Rai (23) S/O Sri Dipak Rai of Coolipara, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
