Sir,

In producing herewith one accused person named Bittu Khan (21) @ Sahid Khan S/o Lt. Md Mahammad Khan of Gurung Busty, ward No.3, P.S- Pradhannagar, Dist. Darjeeling along with following seized articles under proper seizure.

1. One improvised one shooter small fire arms with iron butt measuring 21cm (approx) from barrel to butt, barrel length 10.4 cm (approx), butt length 9 cm (approx), body length 7 cm (approx) having one striking pin, striking hammer and trigger in working condition
2. One round .303 live ammunition.

I ASI Debasish Das of Pradhannagar PS do hereby lodge this written complaint against the above noted accused person named Bittu Khan (21) @ Sahid Khan S/o Lt. Md Mahammad Khan of Gurung Busty, ward No.3, P.S- Pradhannagar, Dist. Darjeeling to the effect that on 26.11.2021 at 18.35 hrs received a source information that one person is moving suspicious at S.N.T Bus stand near Siliguri Junction under Pradhannagar PS with fire arm in his procession for some illegal purpose. Accordingly, I share the information with you and diarized the fact vide PDN PS GDE No. 1451 dtd. 26.11.2021 at 18.35 hrs. Accordingly, being instructed by you myself along with force C/1413 Sujit Sarkar, C/1416 Dilip Kr Barman, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri left for SNT Bus stand. At 18.55 hrs we reached at SNT Bust stand near Siliguri junction and I contacted two persons namely 1) Ram narayan Ram (48) S/O Jayprokash Ram of BRI Colony, Siliguri Junction, P.S-Pradhannagar, Dist. Darjeeling and 2) Dhananjay Barman (25) S/O Biren Barman of Krishn pur, P.S-Tufanganj, Dist. Coochbehar, Presently at Shiba Hotel, Siliguri junction, P.S-Pradhannagar, Dist. Darjeeling and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed.

The source indicated towards one person who was seen moving suspiciously and heading towards SNT bus stand road. Seeing his movement there was reason to believe that he possesses a suspicious article with him. On seeing the police persons, he tried to flee away from the spot. We then chased him and could be able to apprehend him. On interrogation he disclosed his identities as noted above, and then I called two independent witnesses. In presence of witnesses I searched his possession and recovered one improvised one shooter small fire arms with iron butt along with one loaded live ammunition from his left side waist underneath the shirt, I asked him to produce documents in support of his possession of said fire arms, but he failed to produce any valid documents to possess the said arms and ammunition.

Then I seized the above noted arms and ammunition from his conscious and exclusive possession. The whole process of search, seized and label was made in between 19.35 hrs to 20.15hrs. Subsequently, I arrested the accused person named Bittu Khan (21) @ Sahid Khan after informing the ground of arrest and observing all formalities.

In this circumstance, I pray your good office that a specific case may kindly be initiated against the above noted accused person named Bittu Khan (21) @ Sahid Khan S/o Lt. Md Mahammad Khan of Gurung Busty, ward No.3, P.S- Pradhannagar, Dist. Darjeeling under proper section of law and arrange for its investigation.
