Respected Sir,

With due respect, I, Smt. Beauty Paul (Saha), Wife of Sri Dipankar Saha and Daughter of Sri Subrata Paul, residing at C/O. Bipul Kundu, Fuleshwari More, Near Uttarbanga Kshetriya Gramin Bank, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling-734001 (W.B.), beg to state as follows:-

1) That I have entered into marriage with Sri Dipankar Saha, Son of Sri Dilip Kumar Saha who is now residing at Survey No. 164/3/2, Road No. B-8C, Khese Colony, Gurudwara, Lohegaon, Near Dutta Mandir, left from Mobile Tower, Pune-411047, Maharashtra on 03.07.2019 according to Hindu rites and customs and at the time of marriage as per demands of my husband and his father, my father has given gold ornaments, other valuable articles and also given a sum of Rs.50,000/- only to my husband.

2) That after marriage, my husband brought me at Lohegaon, Pune, Maharashtra in their house and after starting conjugal life, my husband and his father have demanded further amount of Rs.1,00,000/- only and when my father could not give the same, my husband and his father namely Dilip Kumar Saha assaulted me by both physically and mentally.

3) That on 18.07.2021 and on 15.08.2021, my husband has physically assaulted me and I sustained bleeding injury.

4) That on 10.09.2021, the father-in-law Dilip Kumar Saha physically assaulted me by pressing my neck and he tried to outrage my modesty.

5) That on 03.10.2021, my husband brought me in the tenanted house of my father situated at Fuleshwari More, P.O. & P.S. Siliguri and he stayed about 3 days and misbehaved with me and my parents and thereafter, he went to Pune leaving me in the tenanted house of my father and thereafter, he threatened me over telephone that if I will go to Pune, he will kill me.

6) That on 12.11.2021, elder sister of my husband namely Rinki Saha, Wife of Sri Bapan Saha of Howli, Dist. Barpeta, Assam and one Sri Dipak Saha of Howli, Dist. Barpeta, Assam who is uncle of my husband of Howli, Dist.

Barpeta, Assam came to the tenanted house of my father and they have demanded a sum of Rs.5,00,000/- only and when we have refused to pay the same, they have misbehaved with us and threatened us with dire consequences.

- 7) That previously, I have not lodged any complaint with a hope that my husband and his relatives will rectify themselves.
- 8) That on 21.11.2021, my husband misbehaved with me over telephone.
- 9) That the offence committed by the above named persons at Pune as well as at the rented house of my father situated at Fuleshwari More, Siliguri within the jurisdiction of the Siliguri Women Police Station, hence this complaint.

So, I therefore, request you to investigate the matter and to take necessary legal action against my husband Sri Dipankar Saha, my father-in-law Sri Dilip Kumar Saha, both are residing at Survey No. 164/3/2, Road No. B-8C, Khese Colony, Gurudwara, Lohegaon, Near Dutta Mandir, left from Mobile Tower, Pune-411047, Maharashtra and elder sister of my husband namely Rinki Saha, Wife of Sri Bapan Saha of Howli, Dist. Barpeta, Assam and uncle of my husband namely Sri Dipak Saha of Hawli, Dist. Barpeta, Assam and punish them according to law. And for this kindness, I shall much oblige to you.
