SUB: FIR AGAINST MD. SHORAB (HUSBAND), SAHARA KHATUN (Mother-in-Law), MD. HASIM (Father-in-Law), MD. SIKANDAR (Brother-in-Law), NAZNI BEGAM (Bhabi), AFSANA BEGAM, HUSNA BEGAM, KHUSBOO BEGAM (Sister-in-Laws) for torturing me and my children

Respected Sir,

With due respect and humble submission I, Farida Khatoun, wife of Md. Shorab, daughter of Late Md. Aslam, resident of Salbari, Post Office- Salbari, Police Station-Pradhan Nagar, District- Darjeeling would like to inform you that I am married to Md. Shorab, s/o Late Md. Hasim, resident of Sarifganj, Nai masjid, Kathihar on 10-11-2012 at Sarifganj, Nai masjid, Kathihar inspite of knowing my family financial condition immediately after marriage, my husband and in-laws started using abusive language at me for not bringing any dowry and forced me to ask my mother to give cash along with the furniture which was denied by my mother after which the tortured of my husband and my in-laws became very severe towards me but considering my marital life and my mother financial condition I used to tolerate the tortured. Seeing my condition and the behavior of my in-laws towards me my mother approached for financial help from my uncle (Chachaji) namely Md. Salim, Md. Kalim, Md. Samil and for saving my marriage they have jointly given 1 set gold ear ring and 1 gold ring to my husband, 2 Silver Anklet, 1 set Silver Bangles, 4 gold Nose pins along with clothes and household articles but my husband and in-laws were not satisfied at all and their hunger for money increased day by day and they started physical torture upon me.

Out of the said wedlock I gave birth to a female child named Shaba Aayat and after birth the level of torture increases day by day and asked me to bring more money from my mother and when I protested they didn't give me food for 3 consecutive days and thereafter they pulled my hair and thrown me along with my daughter out of the house and closed the gate. I waited and remained in the front of the house with a ray of hope that my husband or my in-laws will allow me to enter but no body came to take me back. Seeing my helpless condition my Landlord came forward to help me and my daughter and provided us with food, water and shelter. Thereafter I called my Khala(masi) named Hamida Begam who resides near my matrimonial house at Kathihar came and took me in her home and called my mother and brother hearing this incidence my mother and brother immediately came to Kathihar and brought me to Siliguri. My husband after 1 week came and took me back with the assurance that he and his family members will not commit the same incidence in near future and I considering the future of my child returned back with my husband. After few days again they started abusing me both physically and mentally. Subsequently several meetings were held in presence of relative and well wishers and it was finally decided that my husband will do the work in Siliguri and started residing with my mother and brother at above mentioned address. On 17-03-2020, I gave birth to my son named Md. Azan Ali, when he turn to 4 months my husband took me back to my Matrimonial house at Kathihar where I find there was no mattress in my room. So when I asked my husband to bring house hold articles and basic amenities for residing there, that time my husband became furious an started abusing me with both physically and mentally and said to demand money from my mother to purchase all other household articles as he is not going to bring anything. I started to sleep in floor with my 4 months son later the health of my son gets deteriorated day by day so I was forced to ask money from my home so my mother took money on interest and gave us Bed, showcase, dressing table, side table, etc. but still my husband and in-laws were not satisfied at all. My husband later come to Siliguri for work and never sent a single penny for myself and our two children. One day my daughter misbehaved with me as such I scolded her at that time my Mother-in-law named Sahara Khatun called other neighbors and make a gathering and started creating my bad image in front of them raising false allegation that I used to beat my child unnecessarily, when I opposed it my mother-in-law called my Brother-in-law Md. Sikandar and her wife named Nazni Begam and they beat me with fist and bow. My brother -in- law pulled my hair and my three (3) sisters-in-laws namely 1) Afsana Begam, wife of Md. Suleman and 2) Khusboo Begam wife of Md. Unus all are resident of Sarif Ganj, Kathiar used to come immediately whenever quarrel occurs and starts abusing me in filthy language along with my mother-in-law above-named. It is pertinent to mention here that my sisters-in-laws always abused me without any reason whatsoever. Further my sister-in-law named Husna Begam, wife of Md. Murad resident of Noida, Sector - 16, Metro Station, Delhi always provoked my husband and my in-laws over phone and adds fuel to fire by instigating to inflict more torture upon me. When the situation became unbearable and to save myself and my children life my brother bring me back to parental house on 12.03.2021. That on 17.08.2021 my son was admitted in Siliguri Hospital and got discharged on 19.08.21 but inspite of full knowledge didn't come to meet us. Lastly, on 15-11-2021 at around 5.20 p.m my husband came to my house and assaulted me physically with fist and blow and dashed me in wall with the intention to kill me thereby I received several injuries and threatened me with dire consequences and said in hindi "Tumko aur tumhare bachho ko Zahar khilakar mar dunga". They have also threatened me that if I will lodge any complaint against them than they will kill me and my children and said "Police to paisa dekhkar case ko rafa dafa kar dega".

So, I therefore request before you to kindly look into the matter as per law and take necessary legal action against my husband and all in-laws at the earliest possible manner and due to injuries and bad health unable to lodge F.I.R in due time, delay may be condoned for the ends of justice.
