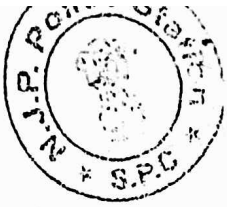

I, NISHA PRASAD, Wife of Rajiv Kumar Paswan, aged about 23 yrs, resident of Madani Bazar, Baribhasa, P.S. NJP, Dist-Jalpaiguri, do hereby beg to inform you the following facts :-

1. That on 26/12/2020 I was married with Rajiv Kumar Paswan, son of Rajesh Paswan, resident of Madani Bazar, Baribhasa, PS-NJP, Dist-Jalpaiguri as per Hindu rites and custom.
2. That at the time of marriage I am a widow and I have one daughter namely AROHI SAHA of ~~26~~ 2½ years of age and my earlier husband died 1 year ago and the said Rajiv Kumar Paswan married me after well know about my earlier marriage.

That after marriage I am residing with my husband Rajiv Kumar Paswan and his family members at my in-laws house at Madani Bazar, Baribhasa, PS-NJP, Dist-Jalpaiguri.

4. That since after my marriage with Rajiv Kumar Paswan my husband and his family members started torture upon me both physically and mentally.
5. That my husband namely Rajiv Kumar Paswan used to scold me physically and beat me regularly by fist and blows and by kicks at my mother in law namely Sharda Paswan, Wife of Rajesh Paswan also used offensive and filthy languages and beat me by holding my hair and other family members namely Rajesh Paswan, son of Not known (father-in-law) and Swaraj Paswan, S/o Rajesh Paswan (Brother-in-law) tried to drive out me from my in-laws house.

6. That my husband shoot my personal viedeo from the mobile and threaten me that if I do not obey his and his family members direction then he put my personal viedeo on social media.
7. That the above name in-laws family members always used to torture me mentally and physically and put me in fear of death and I am residing with my daughter in fear of life.

That on 23/11/2021 at about 12-00 PM my husband and other-in-laws assaulted me by fist and blows and by kicks and my husband hold my neck with intention to kill me and other family members support him and due to their and I got severe injury over my neck and at other parts of body but I somehow manage to escape from their hand and I call my elder sister to save my life then I rscue by my sister and treated by doctor at SD Hospital, Siliguri and now under the treatment of doctor.
9. That I spend my life in a fear condition since after marriage and now my life in daughter at my in-law house.

So, I therefore kindly request you to investigate the matter and take necessary step against the above name persons.
