Madam,

I, **ASHIANA PARVEEN**, W/O. Aarif Abedin, D/O. Abu Saleh, Presently
Residing at Near JSB Life, East Vivekananda Pally, P.O. Rabindra Sarani, P.S.
Siliguri, Dist Darjeeling, do hereby would like to inform you as follows:-

1. That I lodge this F.I.R to the effect that on 30.04.2019, I was married to Aarif Abedin, S/O Joynul Abedin, presently working at Union Bank of India, Ghughumali Branch, P.S. Bhaktinagar Ashigarh Out Post, Dist Jalpaiguri.
2. That the members of my matrimonial house are my husband **AARIF ABEDIN**, father-in-law namely **JOYNUL ABEDIN**, mother in law **ASEFA KHATUN**, who used to stay in my matrimonial house.
3. That the marriage between me and my husband namely Aarif Abedin was registered according Special Marriage Act 1954 on 30.04.2021 before the Marriage Officer Partha Sarathi Deb (Marriage Officer) at CoochBehar, vide Certificate Serial No. 200/2019 and subsequently our social marriage was solemnized as per the customary laws 17.01.2021.
4. That during the marriage negotiations, my husband demanded cash dowry of Rs. 5,00,000/- from my father, and my father has given the cash dowry of Rs. 3,00,000/- (Rupees Three Lakhs Only) to my husband. Moreover gold ornaments of Rs. 9,00,000/- (Rupees Nine Lakh) only to the husband, Bed, Dressing Table, Godrej, Television, Sofa, other wooden furniture totally worth Rs. 2,50,000/- (Rupees Lakh Fifty Thousand), which has been handedover to my father-in-law and Mother -in- law in presence of the other relatives.

5. Thereafter my husband and his parents along with the other relatives showed their dissatisfaction regarding all the dowry articles along with the cash dowry which was given by my family relatives as per their demand and they also criticized my family relatives by saying that all the dowry articles including the cash dowry did not met their expectation.
6. That thereafter after the completion of all the rituals of marriage I along with my husband started living with my in-laws in my matrimonial house situated at Ward No. 14, East Masjid Extention of Ashram Road, P.S. Kotowali, CoochBehar 1, Pin No. 736101.
7. That soon after marriage my husband started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply his demands my husband bang my head on the wall by pouring towel into my mouth so that I cannot scream. Moreover, my husband always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband was never happy with me and always used to taunt me as I had brought insufficient dowry and also demanded from my father to purchase a Flat in Siliguri and whenever I protested angst it then my husband used to abuse me with filthy languages and used doubt on character and my in-laws also used to call me as a Call Girl.
8. That my husband is also short-tempered person, and whenever I disagree with any of his talks or protested for any of his order he used to humiliate in front of everyone and also used slap me at the public places and also used abusive languages upon me and my parents at the public places and to punish me my husband used to use physical intercourse with me.

9. That thereafter in the month of 8th February, 2021 when my husband was going to visit Goa, I asked my husband to take me with him by to Goa then he straight away refused me take him in Goa and when I insisted him then my husband started to slap me and insulted and humiliated in front of everyone used abusive languages one me.
10. That subsequently my husband returned from Goa on 30.04.2021 and after returning my husband started to force me give Divorce to him as he is in affair with another women and when I tried to convince him by putting all my efforts to save this marriage then my husband slapped, pulled my hair and dragged me on the floor and used to have forceful intercourse with me and also forced me to pressurize my father to purchase a Flat for my husband at Siliguri.
11. That subsequently my husband brought me Siliguri for his work purpose as he is the Bank Officer and is presently Union Bank of India, Ghughumali Branch, P.S. Bhaktinagar Ashigarh Out Post, Dist Jalpaiguri.
12. That during his stay in Siliguri, I was residing at my parental house in Rent at Near JSB Life, East Vivekananda Pally, P.O. Rabindra Sarani, P.S. Siliguri, Dist Darjeeling, my husband continuously tortured mentally and always forced me to leave my Job, used abusive languages on my character, suspect my character, insulted me in front my parents and also used abusive languages on my parents.
13. That on 23.11.2021 when I visited at the office of my husband, my husband insulted me in front of the Office Colleague and forced me to give him Divorce otherwise he will spread various false rumours against character in the social media and will destroy my social life and above named in-laws is continuously forcing me to Divorce him and mentally disturbing me due to the harassive, cruel and inhuman acts and conducts and at that time I got mentally ruined and depressed about my life as because my husband and my above named in laws continuously threatening me over telephone and used to abet me to commit suicide.

14. That at present I am residing at my above mentioned address and my husband and in-laws frequently visited my parental house and threatened me that if I donot give him Rs. 5,00,000/- for purchasing a Flat at Siliguri then he will give Divorce to me and will marry another lady.
15. That at present I am living in a very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband & father and mother in law for that lodging of this F.I.R..

I therefore request before your good self to kindly look into the matter and considering the above mentioned unlawful and criminal activities of my husband and my father and mother-in-law kindly take necessary action against my husband and my father and mother-in-law as per your good concern and service rules and for this act of kindness I shall remain extremely grateful to you.
