With due regards, I, **SMT. SMITA PAUL (SAHA)**, Wife of Sri Subham Paul, Daughter of Sri Biplab Saha, Presently residing at Purba Hatiadanga, P.O. Sahudangi, P.S. Bhaktinagar, Dist. Jalpaiguri, in the State of West Bengal, would like to lodge this written complaint to the effect that **SRI SUBHAM PAUL**, Son of Sri Swapan Paul, Resident of C/O - Sri Krishna Paul, Haider Para, Meghhal Sarani, Ward No. 39 of S.M.C., P.O. Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri, is my legally married husband and our marriage was solemnized on 15.03.2018, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from the Sidheswari Kalibari, S.F. Road, Siliguri. Though, our marriage was the outcome of our previous love and affairs but on being agreed by both the family members, we have entered into the said marriage and thereafter, a social marriage ceremony was also performed in presence of our family members, friends and relatives. It is also to be mentioned here that at the time of my marriage, my parents and other family members have given so many valuable articles like golden ornaments, furniture & fixtures, utensils, clothing's and other valuables which are required to start a new conjugal life, as per the demand of my husband and in laws members though, our said marriage was the outcome of our previous love and affairs. After my marriage, my husband brought me at his rented house at C/O - Bengal Tower at Haider Para, Near Shib Sangha Club, Siliguri, where we started to live and co-habited together as husband and wife and in my matrimonial house, besides me and my husband, my father-in-law namely Sri Swapan Paul, mother-in-law namely Smt. Bela Paul and one unmarried sister-in-law namely Smt. Subhasree Paul have also resided there. I entered into my matrimonial house with lots of dream and hope with a view to lead a happy conjugal life with my husband and in laws members. Just after entering into my matrimonial house, my mother-in-law came to my room and asked me to handover all the jewelries and other valuables which are "Stridhan"

in her favour and as per her direction, I have handed over all the jewelries and other valuables to my mother-in-law. After my marriage, I have passed my martial life with my husband and in laws members only for a period of six months. Immediately after lapse of six months, my husband and in-laws members started to create mental torture upon me on various ways and asked me to bring money from my father frequently and sometime, considering the conjugal life, I used to bring money from my father on different plea in order to save my marital relation. Thereafter, my mother-in-law in conspiracy with other in laws members have shifted the entire burden of household works upon me and compelled me to do all the household chores in my matrimonial house and considering my future conjugal life, I have started to work as per their full satisfaction. They did not provide me sufficient foods and sometimes, I used to sleep at night in empty stomach for which, I had fallen ill and during my illness, neither my husband nor my in laws members take any care upon me and did not bother to brought me before the Doctor and as and when, I used to take rest after completion of all the household chores, my mother-in-law in conspiracy with my unmarried sister-in-law has started to taunting me and abused me with filthy and abusive languages. My husband is a Gym Trainer and he has been engaged himself as a Gym Trainer in Gold Gym at Near P.C. Mittal Bus Stand, Sevoke Road, Siliguri and day by day, he turned as a habitual drunker and almost everyday, he used to return back home in fully drunken condition and after returning home, he again started to create inhuman torture upon me and abused me and my family members with filthy and abusive languages and as and when, I made protest, he did not bother to assault me physically. Due to the pendamic situation , Govt. time to time declared Lockdown and after starting the Lock-down due to the pendamic situation, my Husband and my other in-laws members have forced me leave my matrimonial house and asked me to take shelter at my Parental house as they will not bear any expenditure towards my maintenance , fooding , Clothings and medical and due to their said decision, the entire Lock-down period , I have compelled to stay at my parental house and during this period , my husband did not bear any expenditure towards my maintenance and on contrary, he in conspiracy with his other family members , have threatened and started to create pressure upon me to bring money and hand over the same to them from my father. Day by day, they increased the torture

both physically and mentally upon me and they also provoked me either to follow all the demands or to commit suicide. It is very painful to mention here that on 19.06.2021, my husband in conspiracy with my mother-in-law has mortgaged all my golden jewelries at Dropadi Jewellers at Khudiram Pally, Siliguri in my name without giving any information to me. Sir, since last few days, I have been suffering with severe illness and during my illness, I have continuously faced tremendous torture by my husband and in laws members and when I asked them not to inflict such type of torture upon me considering my ill health, they did not pay any heed to my request and thereafter, my father took me before the Doctor and treated me. Suddenly on 24.11.2021, I came to learn about the aforesaid fact and after knowing the said fact, when I asked my husband and my mother-in-law that as to why, they have mortgaged my said jewelries without my permission and consent, they became more furious and started to threaten me with dire consequences and when I raised my voice against their said illegal acts, my husband came at my parental house today and started to threaten me and my parents with dire consequences and also threatened me by saying that if we informed the matter to the police authority, they will not hesitate to ruin our life and property for which, I along with my parents have been passing our days with extreme fear and anxiety.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband Sri Subham Paul, father-in-law Sri Swapan Paul, mother-in-law Sri Bela Paul and unmarried sister-in-law Smt. Subhasree Paul as per the provision of law and obliged thereby.
