Sir,  
In producing herewith the seized Truck bearing regd. no. WB78/2009, Motor Cycle bearing regd no. WB74/AA 7817 (Hero) & WB 74/AU 4322 (Hero Glamour) along with seizure list and lodged a written complaint against the driver and owner of Truck bearing regd. no. WB78/2009.

I SI Partha Sarathi Das O/C Ashighar OP under Bhaktinagar PS, SPC beg to lodge a written complaint against the driver and owner of vehicle no. WB78/2009, to the effect that on 25.11.2021 at around 8 PM received information that one truck bearing registration no. WB78/2009 loaded with boulder was coming from Sevoke side toward Fulbari via Ashighar with an excessive speed and negligently when the said truck reached at Jaleshwari bazaar suddenly lost control due to excessive speed and entered into the fruit shop and became capsized as a result 8/9 persons became serious injured and two numbers motor cycles became damaged. Accordingly I along with SI Pradip Kr Singha ASI Inzamamul Hoque ASI Sumit Barani Nath ASI Amit Mallik C/877 Munna Ahmed C/376 Shyamal Chakraborty & C/603 Arun Roy had been to the spot and rescued the injured persons from the beneath of truck namely (1) Naresh Sarkar S/O Abani Sarkar of Jaleshwari Bazar PS Bhaktinagar Dist. Jalpaiguri (2) Jagodish Debnath S/O Late Jatin Debnath of Madhya Shantinagar PS Bhaktinagar Dist. Jalpaiguri (3) Jaydeb Modak S/O Sunil Modak of Subhashgally PS Siliguri Dist. Darjeeling (4) Ranjan Singh S/O Late Bijan Singh of Dakshin Shantinagar PS Bhaktinagar Dist. Jalpaiguri (5) Rita Dutta W/O Haradhan Dutta of Jaleshwari Bazar PS Bhaktinagar Dist. Jalpaiguri (6) Aaja Dutta S/O Haradhan Dutta of do (7) Kamal Sarkar S/O Santosh Sarkar of do (8) Dhaneshwar Roy S/O Late Satya Narayan Roy of Madhya Shantinagar PS Bhaktinagar Dist. Jalpaiguri and (9) Mata Lanbu W/O Santosh Sarkar of Hatiabanga PS Bhaktinagar Dist. Jalpaiguri and send the above noted injured persons to Siliguri Sadar hospital & NBMC & II for better treatment but the on duty Doctor of Sadar Hospital Siliguri & NBMC & II declare the injured Naresh Sarkar Jagodish Debnath Jaydeb Modak & Ranjan Singh are brought dead. I seized the offending vehicle bearing regd no. WB78/2009 along with the damaged motor Cycles bearing regd no. WB74/AA 7817 (Hero) & WB 74/AU 4322 (Hero Glamour) under proper seizure list, found the driver of offending vehicle is absconding to the spot. During enquiry by contacting with the local public it could be learnt that due to rough & negligent driving of the driver of above truck and over loaded boulder the accident occurred. It could also be learnt that despite of knowing the fact that Jaleswari is a congested Bazaar area where speed was to be under control but the driver did not maintain the speed limit, as result the incident occurred. The driver knows that rough driving may lead to kill the ordinary pedestrians but he to do the same.
