Sir,

In producing herewith (03) three arrested accused persons namely (1) Amit Das @ Babai-30yrs so Tarun Das of Shantinagar, Boubazar near Shantinagar Sporting club, PS Bhaktinagar Dist Jalpaiguri (2) Baban Bhowmik-28yrs s/o Basu Bhowmik of Dasarathpally, Near Munshi Prachand college, ward No-44, PS Bhaktinagar Dist Jalpaiguri and (3) Biswajit Chakroborty @ Choton-26yrs s/o Lt Swapan Chakroborty of Dasarathpally, Near Dasarathpally Bazar, PS Bhaktinagar Dist Jalpaiguri arrested on 22.08.21 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 15 3/4 inch (approx) from the possession of accused Biswajit Chakroborty @ Choton which was kept on his right hand.
2. One iron rod measuring about 20 inch (approx) from the possession of accused Amit Das @ Babai which was kept on his right hand.
3. One iron made KHUKRI (Sharp cutting weapon) approx 17 inch kept in right wrist of accused Baban Bhowmik.

I, SI Srimanta Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 26.11.21 at 23.05 hrs received a sources information that 10/12 youths have assembled at Eastern bye pass road, near Baneswar More under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No- 1551 dated 26.11.21 Subsequently after sharing the information with my superiors and as per their direction, at 23.15 hrs myself along with PSI Sailesh Subba, C/374 Debraj Biswas, CVF/614 Sumit Kumar Roy, CVF/935 Bipllab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman along with kits left for the place to work out the information.. This refers to Bhaktinagar PS G.D.E No 1552 dated 26.11.21 & MCC no-.1907 /21 dated 26.11.21. We reached at Eastern bye pass road, near Baneswar More, under Bhaktinagar PS at 23.25 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 03 (three) accused persons along with seized articles as mentioned above. However, the other six persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhaktinagar PS area. They also stated that another six others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between on 27.11.21 at 00.20 hrs to 01.10 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Amit Das @ Babai-30yrs so Tarun Das of Shantinagar, Boubazar near Shantinagar Sporting club, PS Bhaktinagar Dist Jalpaiguri (2) Baban Bhowmik-28yrs s/o Basu Bhowmik of Dasarathpally, Near Munshi Premchand college, ward No-44, PS Bhaktinagar Dist Jalpaiguri and (3) Biswajit Chakroborty @ Choton-26yrs s/o Lt Swapan Chakroborty of Dasarathpally, Near Dasarathpally Bazar, PS Bhaktinagar Dist Jalpaiguri and six others and arrange for its investigation.
