Sir,

In producing herewith arrested one arrested accused persons namely (1) Kanai Das @ Devdas (21) s/o Manoranjan Das of Gurung Basti, Near Ram Narayan Maath, Ward No. 03, PS Pradhannagar, Dist. Darjeeling under proper memo of arrest along with following seized articles viz:

- 1] Fourteen (14) pieces of vials of DIAZEPAM INJECTION LP each piece of vial containing 2ml, manufacture in India by Vulcan Laboratories Pvt. Ltd P-36Kasba industrial Estate, Phase III, Kolkata, 700107 marked as " Exhibit A" out of which one vial of DIAZEPAM INJECTION LP is taken as sample and marked as " Exhibit A-1".
- 2] Fourteen (14) pieces vials of Promethazine Hydrochloride Injection LP each piece of vial containing 2ml, manufacture by Nitin Lifesciences Ltd. Rampur Road, Poonta Sahib, Dist. Sirmoar, 173025 (H.P.), marked as " Exhibit B" out of which one vial of Promethazine Hydrochloride Injection LP is taken as sample and marked as " Exhibit B-1".
- 3] Thirteen (13) pieces vials of Buprenorphine Injection LP [LUPIGESIC] each piece of vial containing 2 ml, manufacture of SMI Pharmaceuticals Ltd. Vill. Ogh, Solan Pin. 173044 (H.P.) marked as " Exhibit C" out of which one vial of vial Buprenorphine Injection LP is taken as sample and marked as " Exhibit C-1".
- 4] Three (03) pieces of Single use Syringe of 5ml.

I beg to report that on 27.11.2021 at 20.10 Hrs received source information that since few days at evening hours the above noted person is selling contraband substances (Drugs) illegally to local people at Dasrath Pally near TB Hospital, under Bhaktinagar PS without valid license or documents and may be apprehended with such drugs if responded immediately. Accordingly, the matter was diarised vide Bhaktinagar PS GDE no- 1599, Dated 27.11.2021 and after informing your end and without making further delay I along with ASI Dipak Karmakar, C/174 Debraj Biswas, CVF/935 Biplab Roy and CVF/619 Dharmendra Roy all of Bhaktinagar PS rushed to Dasrath Pally. Also, informed Drug Controller Jalpaiguri, over telephone to be present at the spot but due to late night he failed to appear on the spot.

On the way, sought the service of the two persons namely (1) Bappa Karmakar s/o Jagatish Karmakar of Dasrath Pally Bazaar, Ward No. 44, PS Bhaktinagar Dist Jalpaiguri & (2) Sushil Yadav s/o Ram Balan Yadav of Dasrath Pally bazaar, Ward No. 44, PS Bhaktinagar, Dist Jalpaiguri, to stand as witnesses during search and seizure and arrest if required. At 20.35 hrs, reached at the spot and contacted with the source and keeping the Govt vehicle at a distance and started moving towards TB Hospital. As pointed by the

person after observing all formalities and recovered the above noted contraband substances which was kept in his possession.

On interrogation, the apprehended person stated that different statements at different interval of times, which had given rise to suspicion that he has procured the same illegally to dispose clandestinely. Further, on demand, he failed to produce any valid papers or documents in support of such possession of contraband substances. Further, he admitted that he has procured the said recovered substances illegally for consuming them and peddling them to the drug addicts without any prescription.

Accordingly, after observing all formalities, I seized and labelled all the recovered articles under proper seizure list and label duly signed by the witnesses and acknowledged by the accused persons and arrested the apprehended above noted accused person u/s 41 Cr.P.C. All the formalities of seizure and arrest took place in between 21.05 Hrs to 21.55 Hrs.

Under the above circumstances, I pray before you to register a case against the arrested accused person namely Kanai Das @ Devdas s/o Manoranjan Das of Guring Basti, Near Ram Narayan Muttli, Ward No. 03, P.S Pradhannagar, Dist. Darjeeling under proper section of law against and arrange for its proper investigation.
