Sir,

I, Smt. Renuka Chetty, wife of Sri Harka Bahadur Chhetri, Resident of Shalbari Complex, P.O. Sukna, P.S. Pradhan Nagar, District Darjeeling, Pin code No. 734002 lodging this F.I.R. on the following effects with the request for taking immediate action:-

1. That I am the owner of a plot of landed property, measuring about 0.38 acres or 38 decimals of land, situated within the Mouza: Dhukuria (53), under Khatian No: 1956 (L.R), L.R. Plot No.: 16 & R.S. Plot No: 22, under the jurisdiction of Matigara Police Station, District Darjeeling.
2. That in the year 2016 my husband, name by Sri Harka Bahadur Chhetri gifted the scheduled land property to me through one registered Deed of Gift, being No. 3023, Dated: 11/05/2016 and the said document has been registered in the office of A.D.S.R., Siliguri - II (Bagdogra), registered in the Book No. 1, Velum No. 0463-2016, Page from 62705 to 62718, being No. 040303023 for the year 2016 and my husband had become the owners of 2.00 acres of landed property through one registered Deed of Gift, being No. 5216, Dated: 25/09/1981, executed by one Purna Kumari Raini, wife of Dal Bahadur Rai of Salbari, Sukna District: & science the date to up to now I am in possession of my scheduled landed property and I constructed a temporary structure within my landed property.
3. That on 23/11/2021, I had been informed by the local people that 15/20 unknown persons under the leadership of (1) BIJAY KUMAR SAH, S/o late Ram Khelwan Sah Resident of Salbari P.O. Salbari, P.S. Matigara, District Darjeeling, (2) MD. RAJAK, S/o Abdul Mazid, Resident of Damragram, P.O. Gulma, P.S. Pradhan Nagar, District Darjeeling, (3) KAMAL PRADHAN, S/o Late Leela Pradhan, Resident of Salbaro, P.O. Salbari, P.S. Pradhan Nagar, District Darjeeling, (5) PUKAR PRADHAN, S/o Late Garjaman Pradhan, Resident of Salbaro, P.O. Salbari, P.S. Pradhan Nagar, District Darjeeling, tried to take physical possession of one part of my above mentioned landed property (measuring about 10 decimals out of 38 decimals) by uprooting my temporary fencing.
4. That being informed, I went to my landed property also with son and raised objection against their illegal act. At that time those above named persons abused me with filthy language and also told me that I had to vacate my landed property, failing which I should be in trouble but by the intervention of the local people those miscreants left my scheduled landed property with a threat that they would take the physical possession of my landed property & no one could stop them. Being afraid of their physical power, I am approaching you to take adequate legal action, arresting the above named miscreants and to do the needful in accordance with law so as to protect me as well as my property in no time. The matter is very urgent.

Sir, being helpless law abiding lady, I am lodging this F.I.R. to protect my property.
