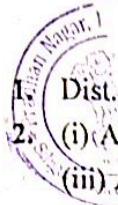

With due respect and humble submission, in producing herewith one accused namely Bhagwan Lal Ray(35) S/O Sri Lal Babu Ray of Debidanga Bazar ,P.S-Pradhannagar,Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) **18(Eighteen) Plastic bottles of Himalayan Gold , Country Spirit ,60 up, each bottle containing 600 ML.**
- ii) **03(Three) bottle of EM Boss Fine whisky ,each bottle containing 750 ML**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 27.11.2021 vide PDN PS GDE NO 1485 dtd. 27.11.21 while I was performing Special Mobile van duty at Debidanga bazaar area with CV/645 Pankaj Gupta ,CV/223 Swapan Chhetri ,During mobile duty at 14.25 hrs I received an information that one person namely Bhagwan Lal Ray has storage huge quantity of illegal liquor in his Hotel styles as " Joyguru Hotel" at Debidanga bazaar under Pradhannagar PS and selling the same in his Hotel .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the said Hotel and detained the hotel of owner noted above and on being search his hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 14.45 hrs to 15.15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Bhagwan Lal Ray(35) S/O Sri Lal Babu Ray of Debidanga Bazar ,P.S-Pradhannagar,Dist.Darjeeling and arrange for its investigation.
