2. 07 (Seven) bottles of Mc Dowels No-1 Celebration Matured XXX RUM Containing 180 Ml in each bottle.

3. 07 (Seven) bottles of Himalayan 70 Up FATA FATI Country spirit containing 300 Ml in each bottle.

4. 10 (Ten) numbers of paper made pouch of officer Choice Deluxe Whisky containing 180 Ml in each pouch.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 26.11.21 at 17.05 hrs I received a secret source information that one person namely Ratan Sarkar of Bansbari, Baribhasa under PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his residence for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1102 dated 26.11.21 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy and VP/13 Jamirul Islam aqnd others all of NJP PS, SPC left for the house Ratan Sarkar of Bansbari, Baribhasa, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 17.45 hrs we arrived at the house of Ratan Sarkar of Bansbari, Baribhasa, PS- NJP, Dist.- Jalpaiguri and being shown and identified by the source I held raid at the house Ratan Sarkar and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 18.15 hrs to 19.25 hrs on 26.11.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ratan Sarkar (55 yrs) S/O late Adhir Sarkar of Basbari, Baribhasa, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
