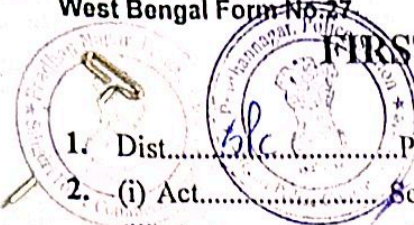

that, I am the owner of bus bearing No. WB 76 B  
0721, on 28th November, 2021 at about 11 am.  
my bus reached Siliguri Junction Bus Stand. From  
Bihar that time one passenger of the Bus, screened  
and tell to my bus staff namely Sancy Kumar  
(Bus Conductor) that he lost his money Rs. 3.5  
Lakh from his waistband after that my staff  
requested to all the passenger of the bus that  
not to leave the bus without checking. After checking  
he found the lost money from one person, half  
blade and some powder from that person namely Goralal  
Mahato, s/o Jinyar Mahato of Madhupur,  
P.O + P.S. Theyria, Dist. Bageswari, Bihar. After that  
my staff handed over to the Victim namely  
Bimod Kumar, s/o Bishwanath Saha, of  
P.S. Bageswari, Dist. Bageswari, Bihar and Victim  
told to my staff that he has been given some  
water to drink by the Goralal Mahato and after  
drinking that water Victim became unconscious  
and that person Goralal Mahato take advantage  
and stole his money from his waistband.
