In producing herewith one person namely Prakash Biswas (46yrs) s/o Pramanda Biswas of Jyotinagar c/o Biplob Bose PS, Bagdogra Dist, Darjeeling along with the following articles under seizure viz.

1. 11 (Eleven) bottles of Kingfisher strong premium Beer (each bottle containing 650 ml) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 01 (One) bottles of Imperial Blue superior grain whisky (each bottle containing 750 ml) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",

I, SI Mijanur Rahaman of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Prakash Biswas (46yrs) s/o Pramanda Biswas of Jyotinagar c/o Biplob Bose PS, Bagdogra Dist, Darjeeling to the effect that today i.e., on 27.11.2021 in course of K-35 Evening mobile duty vide Bagdogra PS, GDE No -1062 Dt, 27.11.2021 at about 19.55 hrs in course of duty received source information that one person is selling illicit liquor at Upper Bagdogra under Flyover bridge namely Prakash Biswas from his stall and huge quantity of illicit liquor is stored in his stall. Accordingly, I shared the information with you and as instructed had been to Upper Bagdogra under Flyover Bridge to work out the information. On reaching there at about 20.15 hrs, I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as mentioned above and stated that he is the owner of the stall while during cordoning of the stall some customers having liquor on his stall beside and fled away. Subsequently the above noted articles were found in the stall of said Prakash Biswas who, being asked failed to produce any valid documents/papers in support of possessing and selling of the illicit liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his stall under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest. The whole process of seizure and labelled was made in between 20.30 hrs to 21.10 hrs. **Total 7.300/= litter's illicit liquors have been seized.**

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Prakash Biswas (46yrs) s/o Pramanda Biswas of Jyotinagar c/o Biplob Bose PS, Bagdogra Dist, Darjeeling and arrange for its investigation.
