Sir,

In producing herewith one arrested person who disclosed his identities namely Sahidur Rahaman (31 yrs) S/O Late Matiur Rahaman of P/A Chandpur, PO- Mirzadpur, PS- Pukuria, Dist- Malda, A/P Sakhtigah 10 No. Gali, C/O B.N Saha, Ward no. 31, PS- NJP, Dist- Jalpaiguri along with the seized articles per seizure list;

1. One improvised type 7.65 mm Pistol iron made fire arms in working condition measuring approx 8.7 inches from barrel to butt having striking pin, hammer, trigger and Magazine,
2. 05 (Five) live ammunition K.F 7.65 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from possession of accused Sahidur Rahaman.
3. One Mahindra 125 Gusto Scooty bearing no. WB74AQ4673.

I Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Sahidur Rahaman (31 yrs) S/O Late Matiur Rahaman of P/A Chandpur, PO- Mirzadpur, PS- Pukuria, Dist- Malda, A/P Sakhtigah 10 No. Gali, C/O B.N Saha, Ward no. 31, PS- NJP, Dist- Jalpaiguri that on 26.11.21 around 13.25 hrs, received a secret source information that one veteran criminal namely Sahidur Rahaman of Shaktigarh and his associate are roaming with the above noted scooty at Ramghat Bridge under Siliguri PS with an ulterior motive and is in possession of firearm. Dairsed the mater vide Siliguri PS GD Entry No. 1530 dated 26.11.21. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Siben Sarkar, ASI Dhruba Misra, CV/622 Ramanath Barman, all Siliguri PS rushed to the place at Ramghat Bridge to verify the veracity of this information vide Siliguri PS G.D.E no. 1533 dated 26.11.21. On way I picked up two disinterested witnesses namely (i) Bijay Tamang (32) S/O Late Birbal Tamanag of Natunpara near Ramghat, Ward No. 05, PS- Siliguri, Dist- Darjeeling and (ii) Malay Das (22) S/O Sri Swapan Das of do, duly informing them about the information in hand. At 13.55 hrs we reached at nearby Ramghat Bridge and as per description of the wearing apparels supplied by the source, we found that two persons in which the above noted accused person was sitting on the riding place and another was sitting on co-rider place in the above noted scooty. On seeing the police party they tried to escape from the place. But we apprehended the above noted person namely Sahidur Rahaman but other one managed to flew away after hot chase. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he along with one Surajit Das were in the Ramghat bridge with the above noted scooty.

Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Sahidur Rahaman was made on search and found that one improvised type 7.65 mm Pistol iron made fire arms loaded with 05 (Five) live ammunition K.F 7.65 unreadable on its percussion cap was recovered which was kept concealed under the jeans trouser on the left side of the above noted accused person's waist. The ammunitions were unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Sahidur Rahaman made incoherent statements and failed to produced any valid documents in support of said seized Firearms.


As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Sahidur Rahaman for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 14.05 hrs and 16.30 hrs. On being further asked the arrested accused person admitted that he along with his associate Surajit Das were present at Ramghat Bridge with an ulterior motive.
