Sir,

In producing herewith one arrested accused person namely Shambhu Sahay (52) S/O Late Kashinath Sahay of Nazrul Sarani bye Lane, (Near Didi Hotel), W/No-15, Hakimpara, PS Siliguri, Darjeeling along with seized articles (1) 15 (Fifteen) bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD Country Spirit of 600 ml each when packed, M.R.P Rs. 120/- each (2) 01 (One) Nylon Bag which used for carrying the seized articles SI no- 1.

I, ASI Gazi Rahaman of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that today on 26.11.21 at 18.45 hrs during spl raid duty I received secret source information that one person is carrying huge quantity of bottle of country spirit through Bidhan road, near Auto stand and proceeded towards Harijan Busty W/No-14 under Panitanki TOP, Accordingly inform the matter to O.C Panitanki TOP and as per his direction I along with, ASI Ratan Ghosh, C/153 Santosh Mahato and CV/1009 Manoj Thakur, left for Bidhan road, near Auto stand to work out the information. On arrival at Bidhan road, near Auto stand, at 19:10 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said persons with loaded articles in presence of Police witnesses. On interrogation the accused person disclosed his name and address as Shambhu Sahay S/O Late Kashinath Sahay of Nazrul Sarani bye Lane, (Near Didi Hotel), W/No-15, Hakimpara, PS Siliguri, Darjeeling. On demand he failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Harijan Busty and its adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 15 (Fifteen) bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD of 600 ml each bottles when packed, MRP Rs. 120/-each and 2) 01 (One) Nylon Bag which used for carrying the seized articles SI No- 1, under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 19:35 hrs to 19:55 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1800/-.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Shambhu Sahay S/O Late Kashinath Sahay for starting a specific case under proper section of Law and to arrange for its investigation.
