With due respect I the undersigned would like to inform you that (1) Md. Alimuddin, S/o. Late Md. Kadir, resident of Adarsha Nagar, Near Gousia Madarsha, W.No.04 of SMC, P.O. Siliguri Bazar, P.S. Siliguri, Dist Darjeeling is my husband's brother. He with his wife (2) Asmin Khatun and his daughter (3) Saheen Anjum are residing at the above mentioned address in a joint Two Storied building opposite our rooms. Those since very long above mentioned accused persons are tiring to illegally evict me and my family from the above mentioned building of my mother In Law.

That today i.e. 25/11/2021 at around 6.30 pm above named accused person No.1 Md. Alimuddin entered in my room and without any reason he started to beat me mercilessly, when I shouted for help his wife Asmin Khatun and his daughter Chandni Khatun entered into my room and they also started beating me.

Somehow I manage to escape from my room and called my aunty and my husband. When my aunty and my husband came to our house above named accused person again assaulted me and my aunty. Above name accused person Md. Alimuddin torn my aunt's salwar and beaten my husband mercilessly and threatened us if we not evict my husband's parental house they will kill us.
