Sir,

In producing herewith one arrested accused person namely Kamini Barman (40) S/O Sri Bhadra Nath Barman of Vitor Kamta Gosani Mari, PO Gosani Mari, PS Dinjata, Cooch Bihar, At present C/O Jayanta Roy, Bdhan Road, Ward No 11, Near Kanchanjanga Lodge PS Siliguri, Darjeeling along with seized articles (1) 20 (Twenty) bottles of 60 UP Country Spirit styled as PET Galaxy Boss Country Sprit of 300 ml each when packed, M.R.P Rs. 50/- each (2) 01 (One) Nylon Bag which used for carrying the seized articles SI no- 1.

I, ASI Ratan Ghosh of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that today on 27.11.21 at 19.15 hrs during evening mobile vand duty I received secret source information that one person is carrying huge quantity of bottle of country spirit through Bidhan road, near Auto stand and proceeded towards Harijon Busty W/No-14 under Panitanki TOP. Accordingly inform the matter to O.C Panitanki TOP and as per his direction I along with, ASI Surajit Mallick, CV 377 Dinesh Roy and CV/1009 Manoj Thakur, left for Bidhan road, near Auto stand to work out the information. On arrival at Bidhan road, near Auto stand, at 19:25 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said persons with loaded articles in presence of witnesses. On interrogation the accused person disclosed his name and address as mentioned above. On demand he failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Harijan Busty and its adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 20 (Twenty) bottles of 60 UP Country Spirit styled as PET Galaxy Boss of 300 ml each bottles when packed, MRP Rs. 50/-each and (2) 01 (One) Nylon Bag which used for carrying the seized articles SI No- 1, under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 19:40 hrs to 20:05 hrs. Then I arrested the above noted accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1000/-.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Kamini Barman S/O Sri Bhadra Nath Barman for starting a specific case under proper section of Law and to arrange for its investigation.
