With due respect I, Sri. Kajal Kundu, S/o. Late Kalyan Kumar Kundu, Proprietor of The Original Dada Bhai Hotel, Bimal Sinha Sarani, Rishi Aurobinda Road By Lane, Ward No. 12 of SMC, Hakimpura, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling beg to state that I have been running a hotel under the name of The Original Dada Bhai Hotel at the above noted address since a long time.

Since last 15(fifteen) days, two antisocial persons of the locality namely (1) Jyotirmoy Das (Debu), S/o. Late N.C. Das and (2) Sri. Netai Paul have been continuously creating many disturbances in my hotel business. On 23/11/2021, they have assaulted my customer badly just because he kept his byke in front of my hotel. The above named Jyotirmoy Das(Debu) and Netai Paul have demanded huge money from me, he has told me that to conduct business in the said area, I have to pay the amount as per their demand. They are continuously and regularly visiting my hotel and threatening me with dire consequences.

Thereafter on several times, the above named antisocials came to my hotel and abused me by saying that if I will not pay them the amount as per their demand, they will kill me and they will also destroy my business. The above named Jyotirmoy Das(Debu) and Netai Paul have been continuously threatening me as and when they found me on the way as they are trying to extort money from me and they have also been continuously threatening me with dire consequences that they will kill me.

Therefore, I request you to kindly look into the matter and to take necessary legal action against the above named (1) Jyotirmoy Das (Debu), S/o. Late N.C. Das and (2) Sri. Netai Paul, resident of Bimal Sinha Sarani, Rishi Aurobinda Road By Lane, Ward No. 12 of SMC, Hakimpura, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling. And for this kindness, I shall much oblige to you.
