Sir,

In producing here with the seized articles viz:-

- (i) 02 (Two) Indane Gas Cylinder partially loaded (domestic)
- (ii) 01 (One) Indane Gas Cylinder empty (domestic)
- (iii) 01 (one) gas pipe length about 03 (three) fit fitted with one gas regulator.

In producing herewith above seized articles under proper seizure list. I SI Goutam Kundu of Enforcement Branch Siliguri Police Commissionerate do hereby lodge the written complaint against the owner namely Laxmi Chettri Sherpa W/O Lt. Ramesh Chettri of Approach road, Bagdogra Airport, PS- Bagdogra owner of Restaurant Styled as "Namrata Restaurant" situated at Approach road, Bagdogra Airport, PS- Bagdogra, Dist- Darjeeling. Who was illegally procured the domestic Gas cylinder at her restaurant styled as "Namrata restaurant" for commercial purpose without any valid documents or license to the effect that today i.e. 29.11.21 at about 13:45 hrs received information from reliable source that one Laxmi Chettri Sherpa W/O Lt. Ramesh Chettri of Approach road, Bagdogra Airport, PS- Bagdogra is using the domestic Gas cylinder at her Restaurant Styled as "Namrata Restaurant" for use commercial purpose for her wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per his direction I, along with SI Pradip Chakraborty, ASI Prashanta Bardhan, ASI Ashoke Biswas, C/424 Manik Roy, and L/C 1270 Deeptina Gazmer all of EB SPC with investigation kit left for Bagdogra PS vide EB SPC M.C.C No 151 /21 Dt.29.11.2021. The matters informed to Bagdogra PS vide Bagdogra PS GDE No. 1151/21 Dt.29.11.2021 and accompanied with K-36 Qrt mobile officer ASI Sadananda Debnath, C/785 R.P Ekka, C/522 Anil Barman all of Bagdogra PS vide Bagdogra PS MCC No 4137 /21 Dt.29.11.21 had been to Approach road, Bagdogra Airport, PS- Bagdogra, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source identification we reached at "Namrata Restaurant" situated at Approach road, Bagdogra Airport, PS- Bagdogra, Dist- Darjeeling and entered into restaurant styled as "Namrata Restaurant" at mentioned address and found worker of Restaurant by using the domestic Indane Gas cylinder without any valid documents for commercial use, on demand they could not produce any valid documents in support of using the indane domestic gas cylinders for commercial purpose. Further local enquiry it is revealed that the above noted female accused person was using the domestic Indane gas cylinder for preparing food items at her Pice Hotel cum Restaurant as a commercial use for her wrongful gain without any valid document. I also managed independent witness namely (1) Manoranjan Dutta S/O Nirmal Dutta C/O Namrata Restaurant, under Bagdogra PS, Dist- Darjeeling (2) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the Restaurant namely Laxmi Chettri Sherpa used the domestic Indane gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles in presence of witnesses after preparing proper seizure list and label. The seizure was made in between 14:45hrs to 15:15 hrs in presence of witnesses.

Hence, I pray before you a specific case may kindly be started under proper section of law against the female accused person Laxmi Chettri Sherpa W/O Lt. Ramesh Chettri of Approach road, Bagdogra Airport, PS- Bagdogra, Dist- Darjeeling owner of Restaurant Styled as "Namrata restaurant" situated at Approach road, Bagdogra Airport, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
