I, Smt. Rita Bhagat W/O Sri Pankaj Bhagat, resident of Pramod Nagar, Tari Jote, P.O. & P.S. Matigara, Dist. Darjeeling, in the State of West Bengal, India, would like to state that today i.e. 30.11.2021 at around 12:30 am I along with my husband was returning home after attending a marriage reception at Bagdogra wherein suddenly near Palpara we were intercepted by few persons namely 1. Sri Pradeep Dutta S/O Unknown, 2. Sri. Piyush Rudra S/O Paritosh Rudra, 3. Sri Vaibhav Rudra S/O Paritosh Rudra and 4. Sri Utkal Rudra S/O Unknown, all are residents of Palpara, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling who were in drunken condition and who without any rhyme or reason started to abuse us and picked up fight with us.

That somehow we managed to leave the said place but they were following us till our house. That at around 1:30 am suddenly we heard our neighbours shouting and to see what had happened when we came out of our house we saw that our vehicle details of which is mentioned herebelow was set in fire by some miscreants. That thereafter we called Matigara Police Station and Fire Brigade, which arrived in a short while and tried to take control of the burning vehicle. That all the documents related to the said vehicle which was kept in the vehicle has burnt.

That we apprehend that the abovementioned persons might be behind this heinous crime as such request your good self to kindly investigate the case and bring the culprits behind the bars so that the law of the land is restored.
