Sir,

With due respect and humble submission I SI Swapan Singha of Bagdogra Traffic Guard lodge this written complainant against one person namely Ashok Basak (40), S/O - Biren Basak, of - Vill - Numbahi, PO - Chandipur, Kazigram, Ps - English Bazar, Dist - Malda and also producing one Mahindra Bolero Van having Reg. No. WB 03 C/0933 (Cash Van).

On 30.11.2021 in course of my duty at Chathat Medical More at 15.45 hrs one Mahindra Bolere Van having Reg. No. WB 03 C/0933 (Cash Van) coming from Siliguri side towards Chathat Medical More with excessive speed with plying hooter wasting no time we blocked the road to stop the Car having Reg. No. WB 03 C/0933. But the driver of the said car managed to escape, After a hot chase towards Bagdogra Side we managed to stop the Car at Sanyasi Mandir we cordoned the Car and the driver to avoid any chance of escape and we disclosed our identity as Police personnel and asked them to get down from the car and asked for the paper of the said Bolero which he was driving. But he failed to produce any valid document regarding the Car or any authorization letter to drive the car. I asked him why he plying the hooter but he unable give any valid reason then the police team search the car on ground of suspicious but found no cash inside the said vehicle. The driver thus fraudulently played the hooter (Siren) for the purpose of cheating for his unknown wrongful gain. Accordingly I seized the Car and later on interrogation he disclosed his identity as noted above and confessed that he without any valid reason driving the car in very excessive speed in dangerous manner and plying hooter then I arrested him after issuing arrest memo.

Under the facts and circumstances I pray before you that a specific case may kindly initiated against the accused person namely Ashok Basak, (40), S/O - Biren Basak, of - Vill - Numbahi, PO - Chandipur, Kazigram, Ps - English Bazar, Dist - Malda under proper section of law against him.
